AN ACT
PROVIDING FOR THE RANK CLASSIFICATION IN THE PHILIPPINE NATIONAL POLICE, AMENDING FOR THE PURPOSE SECTION 28 OF REPUBLIC ACT NO. 6975, AS AMENDED, OTHERWISE KNOWN AS THE "DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT ACT OF 1990"

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. Section 28 of Republic Act No. 6975, otherwise known as the "Department
2 of the Interior and Local Government Act of 1990" is hereby amended to read as
3 follows:

4 "Sec. 28. Rank Classification. – For purposes of **CLARITY OF COMMAND AND**
5 **RESPONSIBILITY, AND FOR THE EFFECTIVE AND** efficient administration,
6 supervision and control, the rank classification of the [members] **UNIFORMED**
7 **PERSONNEL** of the PNP shall be as follows:

8 "[Director General] **POLICE GENERAL**

9 "[Deputy Director General] **POLICE LIEUTENANT GENERAL**

- 1 "[Director] **POLICE MAJOR GENERAL**
- 2 "[Chief Superintendent] **POLICE BRIGADIER GENERAL**
- 3 "[Senior Superintendent] **POLICE COLONEL**
- 4 "[Superintendent] **POLICE LIEUTENANT COLONEL**
- 5 "[Chief Inspector] **POLICE MAJOR**
- 6 "[Senior Inspector] **POLICE CAPTAIN**
- 7 "[Inspector] [**POLICE LIEUTENANT**
- 8 "[Senior Police Officer IV]**POLICE EXECUTIVE MASTER SERGEANT**
- 9 "[Senior Police Officer III] **POLICE CHIEF MASTER SERGEANT**
- 10 "[Senior Police Officer II] **POLICE SENIOR MASTER SERGEANT**
- 11 "[Senior Police Officer I] **POLICE MASTER SERGEANT**
- 12 "[Police Officer III] **POLICE STAFF SERGEANT**
- 13 "[Police Officer II] **POLICE CORPORAL**
- 14 "[Police Officer I] **PATROLMAN/ PATROLWOMAN**

15 SECTION 2. The remaining provisions of Republic Act No. 6975, as
16 amended by Republic Act No. 8551, otherwise known as the 'Philippine National
17 Police Reform and Reorganization Act of 1998', that have reference to the rank
18 classification of the uniformed personnel of the Philippine National Police, and all
19 other laws, executive orders, rules and regulations inconsistent with the
20 provisions of this Act shall be deemed modified or repealed accordingly.

1 SECTION 3. Within thirty (30) days from the effectivity of this Act, the
2 Chief of the Philippine National Police shall issue the necessary rules and
3 regulations for the effective implementation of this Act.

4 SECTION 4. This Act shall take effect fifteen (15) days after its full
5 publication in a newspaper of general circulation.
