AN ACT PROVIDING FOR THE RANK
CLASSIFICATION IN THE PHILIPPINE
NATIONAL POLICE, AMENDING FOR THE
PURPOSE SECTION 28 OF REPUBLIC ACT NO.
6975, AS AMENDED, OTHERWISE KNOWN AS
THE "DEPARTMENT OF THE INTERIOR AND
LOCAL GOVERNMENT ACT OF 1990"

*Be it enacted by the Senate and House of Representatives of
the Philippines in Congress assembled:*

1 SECTION 1. Section 28 of Republic Act No. 6975,
2 otherwise known as the "Department of the Interior and
3 Local Government Act of 1990" is hereby amended to read
4 as follows:

5 "SEC. 28. *Rank Classification.* - For
6 purposes of CLARITY OF COMMAND AND

1 RESPONSIBILITY, AND FOR THE
2 EFFECTIVE AND efficient administration,
3 supervision and control, the rank classification of
4 the [members] UNIFORMED PERSONNEL of
5 the PNP shall be as follows:

6 "[Director General] POLICE GENERAL

7 "[Deputy Director General] POLICE
8 LIEUTENANT GENERAL

9 "[Director] POLICE MAJOR GENERAL

10 "[Chief Superintendent] POLICE
11 BRIGADIER GENERAL

12 "[Senior Superintendent] POLICE COLONEL

13 "[Superintendent] POLICE LIEUTENANT
14 COLONEL

15 "[Chief Inspector] POLICE MAJOR

16 "[Senior Inspector] POLICE CAPTAIN

17 "[Inspector] POLICE LIEUTENANT

18 "[Senior Police Officer IV] POLICE
19 EXECUTIVE MASTER SERGEANT

1 “[Senior Police Officer III] POLICE CHIEF

2 MASTER SERGEANT

3 “[Senior Police Officer II] POLICE SENIOR

4 MASTER SERGEANT

5 “[Senior Police Officer I] POLICE MASTER

6 SERGEANT

7 “[Police Officer III] POLICE STAFF

8 SERGEANT

9 “[Police Officer II] POLICE CORPORAL

10 “[Police Officer I] PATROLMAN/

11 PATROLWOMAN”

12 SEC. 2. The remaining provisions of Republic Act
13 No. 6975, as amended by Republic Act No. 8551, otherwise
14 known as the “Philippine National Police Reform and
15 Reorganization Act of 1998”, that have reference to the
16 rank classification of the uniformed personnel of the
17 Philippine National Police, and all other laws, executive
18 orders, rules and regulations inconsistent with the
19 provisions of this Act shall be deemed modified or repealed
20 accordingly.

1 SEC. 3. Within thirty (30) days from the effectivity of
2 this Act, the Chief of the Philippine National Police shall
3 issue the necessary rules and regulations for the effective
4 implementation of this Act.

5 SEC. 4. This Act shall take effect fifteen (15) days
6 after its full publication in a newspaper of general
7 circulation.
