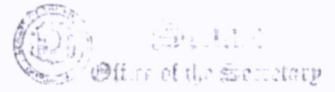

The Committee on Public Works, to which was referred House Bill No. 7844, introduced by Reps. Matugas, Barbers and Lobregat, entitled:



AN ACT RENUMBERING THE SURIGAO DEL NORTE
FIRST AND SECOND DISTRICT ENGINEERING OFFICES
TO CORRESPOND WITH THE LEGISLATIVE DISTRICTS
IN THE PROVINCE OF SURIGAO DEL NORTE

*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

1 SECTION 1. The current district engineering offices in the
2 Province of Surigao del Norte shall be denominated accordingly
3 to correspond with and serve, respectively, the two (2) legislative
4 districts of the province.

5 SEC. 2. The Surigao del Norte First District Engineering
6 Office, to be located within the First Legislative District of the
7 Province of Surigao del Norte shall serve the municipalities
8 of Burgos, Dapa, Del Carmen, General Luna, Pilar, San Benito,
9 San Isidro, Santa Monica and Socorro. The Surigao del Norte
10 Second District Engineering Office, to be located within the Second
11 Legislative District of the Province of Surigao del Norte shall
12 serve the City of Surigao and the municipalities of Alegria, Bacuag,

1 Claver, Gigacuit, Mainit, Malimono, Placer, San Francisco,
2 Sison, Tagana-an and Tubod.

3 SEC. 3. Within thirty (30) days from the approval of this Act,
4 the Secretary of Public Works and Highways shall issue the
5 necessary rules and regulations to carry out the purpose of this Act.

6 SEC. 4. Republic Act No. 4970, constituting the Island
7 of Siargao in the Province of Surigao del Norte into a separate and
8 independent highway engineering district, is repealed accordingly.

9 SEC. 5. This Act shall take effect fifteen (15) days after
10 its publication in the *Official Gazette* or in a newspaper
11 of general circulation.
