



BY REPRESENTATIVE PACQUIAO, PER COMMITTEE REPORT NO. 857

AN ACT SEPARATING THE SITIO OF LADOL FROM BARANGAY POBLACION IN THE MUNICIPALITY OF ALABEL, PROVINCE OF SARANGANI AND CONSTITUTING IT INTO A DISTINCT AND INDEPENDENT BARANGAY TO BE KNOWN AS BARANGAY LADOL

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. *Creation of Barangay Ladol.* – The sitio of Ladol
2 is hereby separated from Barangay Poblacion in the Municipality of
3 Alabel, Province of Sarangani to constitute it into a distinct and
4 independent barangay to be known as Barangay Ladol.

5 SEC. 2. The territorial boundaries of Barangay Ladol are
6 described as follows:

16 *SEC. 3. Conduct and Supervision of Plebiscite.* – The
17 plebiscite conducted and supervised by the Commission on Elections
18 (COMELEC) pursuant to Provincial Ordinance No. 2011-7-048,
19 Series of 2011 of the Sangguniang Panlalawigan of the Province of
20 Sarangani, which ratified the creation of Barangay Ladol as
21 proclaimed by the Plebiscite Board of Canvassers on August 18,
22 2012 shall serve as substantial compliance with the plebiscite
23 requirement under Section 10 of Republic Act No. 7160, as
24 amended, otherwise known as the “Local Government Code of
25 1991”.

26 *SEC. 4. Barangay Officials.* – The incumbent elected
27 barangay officials of Barangay Ladol shall continue to hold office
28 until such time that their successors have been duly elected and
29 qualified.

1 SEC. 5. *Public Infrastructure and Facilities.* – All public
2 infrastructure and facilities for public use existing therein at the
3 time of the approval of this Act are hereby transferred without cost
4 or compensation to and shall be administered by the new Barangay
5 Ladol.

6 SEC. 6. *Internal Revenue Allotment Shares.* – Barangay
7 Ladol shall be entitled to Internal Revenue Allotment (IRA)
8 shares pursuant to Section 285 of Republic Act No. 7160, as
9 amended, otherwise known as the "Local Government Code of
10 1991".

11 SEC. 7. *Effectivity.* – This Act shall take effect fifteen (15)
12 days after its publication in the *Official Gazette* or in a newspaper
13 of general circulation.
