



AN ACT ESTABLISHING AN INTEGRATED SCHOOL IN
BARANGAY MAUWAY, CITY OF MANDALUYONG,
TO BE KNOWN AS THE SENATE PRESIDENT
NEPTALI A. GONZALES INTEGRATED SCHOOL AND
APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

- 1 SECTION 1. *Establishment of an Integrated School.* – There is
2 hereby established, under the supervision of the Department of
3 Education, an integrated school in Barangay Mauway, City of
4 Mandaluyong, National Capital Region, to be known as the Senate
5 President Neptali A. Gonzales Integrated School.
- 6 SEC. 2. *Appropriations.* – The Secretary of Education shall
7 immediately include in the Department's program the
8 operationalization of the Senate President Neptali A. Gonzales
9 Integrated School, the funding of which shall be included in the
10 annual General Appropriations Act.

1 SEC. 3. *Implementation.* - The Secretary of Education shall
2 issue such rules and regulations necessary to carry out the purpose
3 of this Act.

4 SEC. 4. *Effectivity.* - This Act shall take effect fifteen (15)
5 days after its publication in the *Official Gazette*.
