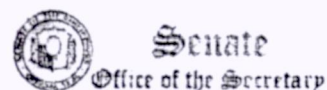



AN ACT ESTABLISHING A LICENSING BRANCH OF THE
LAND TRANSPORTATION OFFICE (LTO) IN THE
CITY OF PARAÑAQUE AND APPROPRIATING FUNDS
THEREFOR

*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

1 SECTION 1. There shall be established a licensing branch of
2 the Land Transportation Office (LTO) in the City of Parañaque.

3 SEC. 2. The Secretary of Transportation shall immediately
4 include in the Department's program the operationalization of the
5 LTO licensing branch in the City of Parañaque, the funding of
6 which shall be included in the annual General Appropriations Act.

7 SEC. 3. This Act shall take effect fifteen (15) days after its
8 publication in the *Official Gazette* or in a newspaper of general
9 circulation.
