



*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

1 SECTION 1. There shall be established a district branch of the
2 Land Transportation Office (LTO) in the Municipality of Maramag,
3 Province of Bukidnon.

4 SEC. 2. The Secretary of Transportation shall immediately
5 include in the Department's program the operationalization of a
6 district branch of the LTO in the Municipality of Maramag,
7 Province of Bukidnon, the funding of which shall be included in the
8 annual General Appropriations Act.

9 SEC. 3. This Act shall take effect fifteen (15) days after its
10 publication in the *Official Gazette* or in a newspaper of general
11 circulation.

EXPLANATORY NOTE

Basic social services are the building blocks for human development, as it is considered a fundamental human right. However, the effective and efficient delivery of these services remains to be a continuing issue in our country.

The 1987 Constitution lays out a specific section on Accountability of Public Officers. It states that public officers and employees must at all times be accountable to the people, serve them with utmost responsibility, integrity, loyalty, and efficiency. It is of important value that public needs and concerns must at all times be served and addressed.

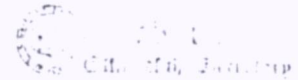
This bill seeks to provide the people of Mindanao with efficient license approval and renewal services by establishing a Land Transportation Office (LTO) District Branch in the Municipality of Maramag, Province of Bukidnon. The creation of this branch would ease the docket congestion of surrounding LTO Offices and would provide an option for the people of Maramag and surrounding areas who, at present, still have to travel to the nearest LTO office located in Malaybalay, Bukidnon.

In view of the foregoing, the approval of this bill is earnestly sought.

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

1 **Section 1. Declaration of Policy** – Pursuant to Article XII, Section 1 of the
2 1987 Philippine Constitution that the goals of the national economy are a more
3 equitable distribution of opportunities, income and wealth, the State hereby
4 adopts a policy to ensure quality service to the public and that appropriate
5 number of competent human resources may be supplied to answer the call for
6 bringing government services closer to the people. To this end, the State shall
7 ensure the expeditious renewal and application of driver's licenses and car
8 registrations.
9

10 **Sec. 2.** There shall be established a district branch of the Land
11 Transportation Office (LTO) to be located in the Municipality of Maramag, located
12 in the 3rd District of Bukidnon.
13

14 **Sec. 3.** The Chairperson of the LTO shall immediately include in the
15 Office's programs the operationalization of the LTO Branch in the Municipality of
16 Maramag. The initial funding for the implementation of this Act shall be sourced
17 from the appropriations for the Department of Transportation under the General
18 Appropriations Act. Thereafter, the appropriate funding for the operation and
19 maintenance of the foregoing LTO District Branch shall be included in the annual
20 General Appropriations Act.
21

22 **Sec. 4.** The Chairperson of the LTO shall issue such rules and regulations
23 as may be necessary to carry out the purpose of this Act.
24

25 **Sec. 5. Separability Clause.** – If any provision of this Act shall be held
26 unconstitutional or invalid, the other provisions not otherwise affected shall
27 remain in full force and effect.
28

29 **Sec. 6. Repealing Clause.** – All laws, executive orders, rules and
30 regulations inconsistent with or contrary to this Act are hereby deemed
31 accordingly repealed or amended.
32

1 **Sec. 7. Effectivity Clause.** – This Act shall take effect after fifteen (15)
2 days from publication in at least two (2) newspapers of general circulation.
3
