

*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

SECTION 1. There shall be established, under the supervision
of the Land Transportation Office (LTO) Main Office in Quezon
City, a satellite office of the LTO in the Municipality of Kibawa,
Province of Bukidnon.

SEC. 2. The Secretary of Transportation shall immediately
include in the Department's program the operationalization of the
LTO Satellite Office in the Municipality of Kibawa, Province of
Bukidnon, the funding of which shall be included in the annual
General Appropriations Act.


SEC. 3. This Act shall take effect fifteen (15) days after its
publication in the *Official Gazette* or in a newspaper of general
circulation.

EXPLANATORY NOTE

The 1987 Constitution states that public officers and employees must at all times be accountable to their countrymen, serve them with utmost professionalism, competence, integrity, loyalty, and efficiency. It is, thus, imperative to ensure the effective and efficient delivery of government services to the public, including those residing in far-flung areas.

This proposed bill seeks to set up a Land Transportation Office (LTO) Satellite Branch in the Municipality of Kibawe, Province of Bukidnon. At present, motor vehicle users in Kibawe and neighboring areas still have to travel sixty (60) kilometers to the nearest LTO branch located in the Municipality of Maramag. Aside from the long commute, transacting clients will also have to go to one of only three LTO offices in Bukidnon, a province that, according to available data from the Philippine Statistics Authority, registered more than 35,000 motor vehicles in the year 2012.

This measure aims to bring efficient motor vehicle registration and license approval and renewal services closer, not only to the people of Kibawe, but to those residing in surrounding areas as well.

In view of the foregoing, the approval of this bill is earnestly sought.

*Be it enacted by the Senate and the House of Representatives of the Philippines
in Congress assembled:*

1 **Section 1. Declaration of Policy** – Pursuant to Article XII, Section 1 of
2 the 1987 Philippine Constitution that the goals of the national economy are a
3 more equitable distribution of opportunities, income and wealth, the State
4 hereby adopts a policy to ensure quality service to the public and that
5 appropriate number of competent human resources maybe supplied by the
6 management to answer the call of bringing the services much closer to the
7 public. Towards this end, the State ensures the expeditious renewal and
8 application of driver's license and car registration.
9

10 **Sec. 2.** There shall be established under the supervision of the Land
11 Transportation Office (LTO) Main Office in Quezon City, a satellite office of the
12 LTO in the Municipality of Kibawe, Province of Bukidnon.
13

14 **Sec. 3.** The Chairperson of the LTO shall immediately include in the
15 Office's program the operationalization of the LTO Satellite Office in the
16 Municipality of Kibawe, Province of Bukidnon. The initial funding for the
17 implementation of this Act shall be sourced from the appropriations for the
18 Department of Transportation under the General Appropriations Act. Thereafter,
19 the appropriate funding for the operation and maintenance of the foregoing LTO
20 Satellite Office shall be included in the annual General Appropriations Act.
21

22 **Sec. 4.** The Chairperson of the LTO shall issue such rules and regulations
23 as may be necessary to carry out the purpose and objective of this Act.
24

25 **Sec. 5. Separability Clause.** – If any provision of this Act shall be held
26 unconstitutional or invalid, the other provisions not otherwise affected shall
27 remain in full force and effect.
28

29 **Sec. 6. Repealing Clause.** – All laws, executive orders, rules and
30 regulations inconsistent with or contrary to this Act are hereby deemed
31 accordingly repealed or amended.

Sec. 7. Effectivity Clause. – This Act shall take effect after fifteen (15) days from publication in at least two (2) newspapers of general circulation.
