- AN ACT ESTABLISHING AN EXTENSION OFFICE OF THE LAND TRANSPORTATION OFFICE (LTO) IN THE MUNICIPALITY OF TUBIGON, PROVINCE OF BOHOL AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. There shall be established, under the supervision 2 of the Land Transportation Office (LTO) Bohol District Office, an 3 LTO Extension Office in the Municipality of Tubigon, Province of 4 Bohol.

5 SEC. 2. The Secretary of Transportation shall immediately 6 include in the Department's program the operationalization of the 7 LTO Extension Office in the Municipality of Tubigon, Province of 8 Bohol, the funding of which shall be included in the annual General 9 Appropriations Act.

10 SEC. 3. The Secretary of Transportation shall issue the 11 necessary rules and regulations within ninety (90) days from the 12 effectivity of this Act. 1 SEC. 4. This Act shall take effect fifteen (15) days after its 2 publication in the Official Gazette or in a newspaper of general 3 circulation.
