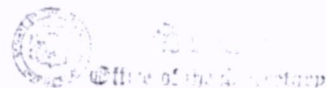





AN ACT CONVERTING THE GUIMARAS LAND
TRANSPORTATION OFFICE (LTO) EXTENSION
OFFICE INTO A REGULAR LTO DISTRICT OFFICE

*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

1 SECTION 1. This Act shall be known as the "Act Converting
2 the Guimaras Land Transportation Office (LTO) Extension Office
3 Into a Regular LTO District Office."

4 SEC. 2. The existing Guimaras LTO Extension Office is
5 hereby converted into a regular LTO District Office.

6 SEC. 3. For this purpose, the Secretary of the Department of
7 Transportation shall immediately include in the Department's
8 program the operationalization of the regular LTO District Office in
9 the Province of Guimaras, the initial funding of which shall be
10 charged against the current year's appropriations of the extension
11 office located in the Province of Guimaras. Thereafter, such sums
12 as may be necessary for the continued operation of the new

1 Guimaras LTO District Office shall be included in the annual
2 General Appropriations Act.

3 SEC. 4. This Act shall take effect after fifteen (15) days
4 following its publication in two (2) newspapers of general
5 circulation.
