





AN ACT ESTABLISHING A DISTRICT OFFICE OF THE
LAND TRANSPORTATION OFFICE (LTO) IN THE
MUNICIPALITY OF MAMBURAO, PROVINCE OF
OCCIDENTAL MINDORO AND APPROPRIATING FUNDS
THEREFOR

*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

1 SECTION 1. There shall be established a district office of the
2 Land Transportation Office (LTO) in the Municipality of Mamburao,
3 Province of Occidental Mindoro.

4 SEC. 2. The Secretary of Transportation shall immediately
5 include in the Department's programs the operationalization of the
6 LTO District Office in the Municipality of Mamburao, Province of
7 Occidental Mindoro, the funding of which shall be included in the
8 annual General Appropriations Act.

9 SEC. 3. This Act shall take effect fifteen (15) days after its
10 publication in the *Official Gazette* or in a newspaper of general
11 circulation.
