Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. March 1 of every year is hereby declared a special nonworking holiday in the City of Davao, Province of

- 9 SEC. 4. This Act shall take effect fifteen (15) days after its
