



AN ACT GRANTING PHILIPPINE CITIZENSHIP TO MOHAMAD
WASSIM NANAA

*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

1 SECTION 1. Mr. Mohamad Wassim Nanaa is hereby granted
2 Philippine citizenship with all the rights, privileges and
3 prerogatives, as well as the duties and obligations appurtenant
4 thereto.

5 SEC. 2. Mr. Mohamad Wassim Nanaa shall take the Oath of
6 Allegiance to the Republic of the Philippines before an officer duly
7 authorized to administer the same. The Oath of Allegiance shall be
8 registered with the Bureau of Immigration.

9 SEC. 3. Upon registration of the Oath of Allegiance, the
10 Bureau of Immigration shall issue a Certificate of Naturalization to
11 Mr. Mohamad Wassim Nanaa who shall thereupon enter into the
12 full enjoyment of Philippine citizenship.

1 SEC. 4. This Act shall take effect fifteen (15) days after its
2 publication in the *Official Gazette* or in any newspaper of general
3 circulation.
