AN ACT AMENDING SECTION 10(b) OF REPUBLIC ACT  
NO. 10160, OTHERWISE KNOWN AS THE "CHARTER OF  
THE CITY OF BACOR"

*Be it enacted by the Senate and House of Representatives of the  
Philippines in Congress assembled:*

1           SECTION 1. Section 10(b) of Republic Act No. 10160,  
2 otherwise known as the "Charter of the City of Bacor", is hereby  
3 amended to read as follows:

4           "SEC. 10. *Composition.* - (a) The sangguniang  
5           panlungsod, the legislative body of the City, shall be  
6           composed of the city vice mayor as the presiding officer,  
7           the twelve (12) regular sanggunian members, the  
8           president of the city chapter of the liga ng mga  
9           barangay, the president of the panlungsod na  
10          pederasyon ng mga sangguniang kabataan and the  
11          three (3) sectoral representatives, as members, who  
12          shall come from the following sectors: one (1) from the  
13          women sector; and, as shall be determined by the  
14          sangguniang panlungsod within ninety (90) days prior

1 to the holding of the local elections, one (1) from the  
2 agricultural or industrial workers sector; and one (1)  
3 from the other sectors, including urban poor, indigenous  
4 cultural communities or persons with disabilities.

5 "(b) The regular members of the sangguniang  
6 panlungsod and sectoral representatives shall be elected  
7 in the manner as may be provided by law: *Provided,*  
8 That for purposes of representation in the sangguniang  
9 panlungsod, six (6) regular members shall be elected  
10 from each of the following districts by barangay, each  
11 district comprising a compact, contiguous and adjacent  
12 territory:

13 "Bacoor West - Alima, Aniban, Aniban II, Aniban  
14 III, Aniban IV, Aniban V, Banalo, Camposanto, Daang  
15 Bukid, Digmaan, Dulong Bayan, Habay I, Habay II,  
16 Kaingin, Ligas I, Ligas II, Ligas III, Mabolo I, Mabolo  
17 II, Mabolo III, Maliksi I, Maliksi II, Maliksi III, Niog I,  
18 Niog II, Niog III. [P.F. Espiritu I, P.F. Espiritu II,  
19 P.F. Espiritu III, P.F. Espiritu IV, P.F. Espiritu V,  
20 P.F. Espiritu VI, P.F. Espiritu VII, P.F. Espiritu VIII.]  
21 PANAPAAN I, PANAPAAN II, PANAPAAN III, PANAPAAN  
22 IV, PANAPAAN V, PANAPAAN VI, PANAPAAN VII,  
23 PANAPAAN VIII, Real I, Real II, Salinas I, Salinas II,  
24 Salinas III, Salinas IV, San Nicolas I, San Nicolas II,  
25 San Nicolas III, Sineguelasan, Tabing Dagat, Talaba I,  
26 Talaba II, Talaba III, Talaba IV, Talaba V, Talaba VI,

1 Talaba VII, Zapote I, Zapote II, Zapote III, [and] Zapote  
2 IV, AND ZAPOTE V.

3 "Bacoor East - Bayanan, Mambog I, Mambog II,  
4 Mambog III, Mambog IV, Mambog V, Molino I, Molino  
5 II, Molino III, Molino IV, Molino V, Molino VI, Molino  
6 VII, Queens Row Central, Queens Row East, and  
7 Queens Row West."

8 SEC. 2. This Act shall take effect fifteen (15) days after its  
9 publication in the *Official Gazette* or in a newspaper of general  
10 circulation.
