

AN ACT SEPARATING THE CITY OF MANDAUE FROM THE  
SIXTH LEGISLATIVE DISTRICT OF THE PROVINCE OF  
CEBU TO CONSTITUTE THE LONE LEGISLATIVE  
DISTRICT OF THE CITY OF MANDAUE

*Be it enacted by the Senate and House of Representatives of the  
Philippines in Congress assembled:*

1           SECTION 1. The City of Mandaue is hereby separated from  
2 the Sixth Legislative District of the Province of Cebu to constitute  
3 the Lone Legislative District of the City of Mandaue, which shall  
4 commence in the next national and local elections after the  
5 effectivity of this Act.

6           SEC. 2. The incumbent Representative of the present Sixth  
7 Legislative District of the Province of Cebu shall continue to  
8 represent the said district until the new Representative of the Lone  
9 Legislative District of the City of Mandaue shall have been elected  
10 and qualified.

1           SEC. 3. The Commission on Elections shall issue the  
2 necessary rules and regulations to implement the provisions of this  
3 Act within thirty (30) days after its effectivity.

4           SEC. 4. All laws, rules and regulations which are inconsistent  
5 with this Act are hereby repealed, amended or modified accordingly.

6           SEC. 5. This Act shall take effect fifteen (15) days after its  
7 publication in the *Official Gazette* or in a newspaper of general  
8 circulation.
