**Mr. President:**

The Committees on Health and Demography, and Finance, to which was referred House Bill No. 8435, introduced by Representatives Jonas C. Cortes, Peter D. Calderon, Tom S. Villarín and Karlo Alexei B. Nograles, entitled:

**AN ACT**

**UPGRADING THE EVERSLEY CHILDS SANITARIUM HOSPITAL IN MANDAUE CITY, PROVINCE OF CEBU, INTO A GENERAL HOSPITAL TO BE KNOWN AS THE EVERSLEY CHILDS SANITARIUM AND GENERAL HOSPITAL, INCREASING ITS BED CAPACITY FROM FIFTY (50) BEDS TO TWO HUNDRED (200) BEDS AND APPROPRIATING FUNDS THEREFOR**

have considered the same and have the honor to report back to the Senate with the recommendation that the attached House Bill No. 8435 be approved with the following amendments:

1. On Page 1, delete lines 1-4 and replace it with the following:

**SECTION 1. THE AUTHORIZED FIFTY (50) BEDS FOR GENERAL HOSPITAL SERVICES OF THE EVERSLEY CHILDS SANITARIUM**

**HOSPITAL IN MANDAUE CITY, PROVINCE OF CEBU IS HEREBY INCREASED TO TWO HUNDRED (200) BEDS, THEREBY REAPPORTIONING THE AUTHORIZED FIVE HUNDRED (500) BED CAPACITY OF THE SAID HOSPITAL. THE REMAINING THREE HUNDRED BEDS (300) ARE FOR LEPROSY SERVICES. THE EVERSLEY CHILDS SANITARIUM HOSPITAL SHALL BE RENAMED AS THE EVERSLEY CHILDS SANITARIUM AND GENERAL HOSPITAL.**

2. On Page 1, delete lines 5-9 until Page 2, lines 1-2 (SEC. 2).
3. Renumber the succeeding Sections accordingly.
4. On Page 2, line 5, between the words "Hospital" and " hereby", delete the word "is" and replace with "**ARE**". On line 5, between the words "the" and "in", delete the phrase "increase in" and replace it with the phrase "**REAPPORTION OF**". On line 6, between the words "Section" and "of", delete "2" and replace it with "**1.**"
5. On the same page, line 8, between the words "The" and "DOH", insert the phrase "**THE DEPARTMENT OF HEALTH**" and put parentheses in the acronym "DOH".
6. On the same page, after line 17, insert a new Section, which shall read as follows:

**SEC. 4. IF ANY PROVISION OR PART OF THIS ACT IS DECLARED UNCONSTITUTIONAL THE REMAINING PARTS OR PROVISIONS NOT AFFECTED SHALL REMAIN IN FULL FORCE AND EFFECT.**
7. Delete the title of the bill and replace it with the following:

**AN ACT**  
**INCREASING THE BED CAPACITY FOR GENERAL HOSPITAL SERVICES OF THE EVERSLEY CHILDS SANITARIUM HOSPITAL IN MANDAUE CITY, PROVINCE OF CEBU, FROM FIFTY (50) BEDS TO TWO HUNDRED BEDS, RENAMING THE HOSPITAL AS THE EVERSLEY CHILDS SANITARIUM AND GENERAL HOSPITAL, AND APPROPRIATING FUNDS THEREFOR**







AN ACT UPGRADING THE EVERSLEY CHILDS SANITARIUM  
HOSPITAL IN MANDAUE CITY, PROVINCE OF CEBU,  
INTO A GENERAL HOSPITAL TO BE KNOWN AS THE  
EVERSLEY CHILDS SANITARIUM AND GENERAL  
HOSPITAL, INCREASING ITS BED CAPACITY FROM  
FIFTY (50) BEDS TO TWO HUNDRED (200) BEDS AND  
APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the  
Philippines in Congress assembled:*

1           SECTION 1. The Eversley Childs Sanitarium Hospital in  
2 Mandaue City, Province of Cebu is hereby upgraded into a general  
3 hospital to be known as the Eversley Childs Sanitarium and  
4 General Hospital.

5           SEC. 2. The authorized bed capacity of the Eversley Childs  
6 Sanitarium and General Hospital in Mandaue City, Province of  
7 Cebu, is hereby increased from fifty (50) beds to two hundred (200)  
8 beds. The Secretary of the Department of Health (DOH) shall  
9 implement the increase in bed capacity of the Eversley Childs

1 Sanitarium and General Hospital consistent with the five (5)-year  
2 development plan of the hospital.

3 SEC. 3. The existing service facilities and professional health  
4 care services of the Eversley Childs Sanitarium and General  
5 Hospital is hereby upgraded, commensurate to the increase in its  
6 authorized bed capacity as provided in Section 2 of this Act.

7 The existing workforce of the Eversley Childs Sanitarium and  
8 General Hospital shall be increased correspondingly. The DOH  
9 shall, in coordination with the Department of Budget and  
10 Management and the Civil Service Commission, and after  
11 consultation with the Eversley Childs Sanitarium and General  
12 Hospital, determine the additional plantilla positions to be created  
13 and filled up,

14 SEC. 4. The Secretary of Health shall immediately include in  
15 the Department's programs the implementation of this Act, the  
16 funding of which shall be included in the annual General  
17 Appropriations Act.

18 SEC. 5. All laws, decrees, rules and regulations inconsistent  
19 with this Act shall be deemed amended or repealed accordingly.

20 SEC. 6. This Act shall take effect fifteen (15) days after its  
21 publication in the *Official Gazette* or in a newspaper of general  
22 circulation.
