Re: House Bill No. 8248.

Recommending the approval of House Bill No. 8248 with amendments.

Sponsor: Senator Joseph Victor G. Ejercito

#### Mr. President:

The Committees on Health and Demography, and Finance, to which was referred House Bill No. 8248, introduced by Representatives Elisa Kho and Karlo Alexei B. Nograles, entitled:

#### AN ACT

INCREASING THE BED CAPACITY OF THE MASBATE PROVINCIAL HOSPITAL IN MASBATE CITY, PROVINCE OF MASBATE, FROM ONE HUNDRED TWENTY-FIVE (125) TO TWO HUNDRED (200) BEDS, UPGRADING ITS SERVICES AND FACILITIES, AUTHORIZING THE INCREASE OF ITS MEDICAL PERSONNEL AND APPROPRIATING FUNDS THEREFOR

have considered the same and have the honor to report back to the Senate with the recommendation that House Bill No. 8248 be approved with the following amendments:

On Page 1, lines 4-5, between the words "beds" and "which", delete the comma (,) and also delete the phrase "which shall be implemented for a period of not more than two (2) years from the approval of this Act." Replace the comma with a colon (:) and insert the phrase "PROVIDED, THAT THE HOSPITAL SHALL COMPLY WITH THE LICENSING REQUIREMENTS OF THE DEPARTMENT OF HEALTH (DOH)." Then add the following

- sentence: "THE INCREASE IN THE BED CAPACITY OF THE MASBATE PROVINCIAL HOSPITAL SHALL BE IMPLEMENTED CONSISTENT WITH THE HOSPITAL'S DEVELOPMENT PLAN."
- 2. On Page 2, after line 7, insert two new Sections, which shall read as follows:
  - SEC. 4. IF ANY PROVISION OR PART OF THIS ACT IS DECLARED UNCONSTITUTIONAL THE REMAINING PARTS OR PROVISIONS NOT AFFECTED SHALL REMAIN IN FULL FORCE AND EFFECT.
    - SEC. 5. ALL OTHER LAWS, DECREES, ORDERS, ISSUANCES, RULES AND REGULATIONS, OR PARTS THEREOF WHICH ARE INCONSISTENT WITH THE PROVISIONS OF THIS ACT ARE HEREBY REPEALED, AMENDED OR MODIFIED ACCORDINGLY.
- 3. Renumber the succeeding Section accordingly.

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. The authorized bed capacity of the Masbate

SEC. 2. The Provincial Government of Masbate shall provide

4	SEC. 3. The head of the Masbate Provincial Hospital, in
5	coordination with the Provincial Government of Masbate, shall
6	determine the additional positions to be created and filled up
7	corresponding to the increase in bed capacity of the hospital.
8	SEC. 4 This Act shall take effect fifteen (15) days after its
9	publication in the Official Gazette or in a newspaper of general
10	circulation.
