Recommending the approval of House Bill No. 7811 with amendments.

Mr. President:

The Committees on Health and Demography, and Finance, to which was referred House Bill No. 7811, introduced by Representatives Florida "Rida" P. Robes and Karlo Alexei B. Nograles, entitled:

**AN ACT  
ESTABLISHING A SPECIALTY HOSPITAL IN THE CITY OF SAN  
JOSE DEL MONTE, PROVINCE OF BULACAN, TO BE KNOWN AS  
ST. BERNADETTE CHILDREN AND MATERNITY HOSPITAL, AND  
APPROPRIATING FUNDS THEREFOR**

have considered the same and have the honor to report back to the Senate with the recommendation that House Bill No. 7811 be approved with the following amendments:

1. On Page 1, line 5, after the word "Bulacan.", add as second sentence the following: **THE ST. BERNDADETTE CHILDREN AND MATERNITY HOSPITAL SHALL BE UNDER THE ADMINISTRATIVE AND TECHNICAL SUPERVISION OF SAN JOSE DEL MONTE CITY, PROVINCE OF BULACAN."**

2. On Page 1, delete lines 6-11 (SEC. 2).
3. On Page 2, delete lines 1-5 (SEC. 3) and lines 6-8 (SEC. 4). Replace with following new Sections:

**SEC. 2. THE CITY GOVERNMENT OF SAN JOSE DEL MONTE IN THE PROVINCE OF BULACAN SHALL PROVIDE FUNDING FOR THE ESTABLISHMENT, OPERATION AND MAINTENANCE OF THE ST. BERNADETTE CHILDREN AND MATERNITY HOSPITAL.**

**SEC. 3. THE SECRETARY OF HEALTH SHALL INCLUDE IN THE DEPARTMENT'S PROGRAM THE SUBSIDY SUPPORT FOR THE CAPITAL OUTLAY REQUIREMENTS FOR THE ESTABLISHMENT OF THE SAID SPECIALTY HOSPITAL, THE FUNDING OF WHICH SHALL BE INCLUDED IN THE ANNUAL GENERAL APPROPRIATIONS ACT.**

**SEC. 4. IF ANY PROVISION OR PART OF THIS ACT IS DECLARED UNCONSTITUTIONAL THE REMAINING PARTS OR PROVISIONS NOT AFFECTED SHALL REMAIN IN FULL FORCE AND EFFECT.**

**SEC. 5. ALL OTHER LAWS, DECREES, ORDERS, ISSUANCES, RULES AND REGULATIONS, OR PARTS THEREOF WHICH ARE INCONSISTENT WITH THE PROVISIONS OF THIS ACT ARE HEREBY REPEALED, AMENDED OR MODIFIED ACCORDINGLY.**

4. Renumber the succeeding Section<sup>3</sup> accordingly.





AN ACT ESTABLISHING A SPECIALTY HOSPITAL IN THE  
CITY OF SAN JOSE DEL MONTE, PROVINCE OF  
BULACAN, TO BE KNOWN AS ST. BERNADETTE  
CHILDREN AND MATERNITY HOSPITAL, AND  
APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the  
Philippines in Congress assembled:*

1       SECTION 1. There shall be established a specialty hospital,  
2       known as St. Bernadette Children and Maternity Hospital, with  
3       a minimum capacity of one hundred (100) beds, to be located at  
4       Barangay Graceville, City of San Jose Del Monte, Province of  
5       Bulacan.

6       SEC. 2. The St. Bernadette Children and Maternity Hospital  
7       shall be under the full administrative and technical supervision  
8       of the Department of Health, which shall increase its operating  
9       fund, upgrade its medical equipment and facilities, and  
10      correspondingly construct the necessary infrastructure to  
11      implement the increase in bed capacity authorized herein.

1        SEC. 3. The Secretary of Health shall include in the  
2 Department's program the establishment and operationalization of  
3 St. Bernadette Children and Maternity Hospital, the funding of  
4 which shall be included in the budget of the Department of Health  
5 under the annual General Appropriations Act.

6        SEC. 4. The Secretary of Health shall promulgate within sixty  
7 (60) days the implementing rules and regulations for the effective  
8 implementation of the provisions of this Act.

9        SEC. 5. This Act shall take effect fifteen (15) days after its  
10 publication in the *Official Gazette* or in any newspaper of general  
11 circulation.
