The Committees on Health and Demography, and Finance, to which was referred House Bill No. 7037, introduced by Representatives Bai Sandra A. Sema and Karlo Alexei B. Nograles, entitled:

AN ACT

1. On Page 2, after line 8, insert two new Sections, which shall read as follows:


SEC. 4. IF ANY PROVISION OR PART OF THIS ACT IS DECLARED UNCONSTITUTIONAL THE REMAINING PARTS OR PROVISIONS NOT AFFECTED SHALL REMAIN IN FULL FORCE AND EFFECT.

SEC. 5. ALL OTHER LAWS, DECREES, ORDERS, ISSUANCES, RULES AND REGULATIONS, OR PARTS THEREOF WHICH ARE INCONSISTENT WITH THE PROVISIONS OF THIS ACT ARE HEREBY REPEALED, AMENDED OR MODIFIED ACCORDINGLY.

2. Renumber the succeeding Section accordingly.







CAPACITY DISTRICT HOSPITAL TO BE NOW KNOWN
AS THE DATU ODIN SINSUAT DISTRICT HOSPITAL,
UPGRADING ITS FACILITIES AND PROFESSIONAL
HEALTH CARE, AUTHORIZING THE INCREASE OF ITS
MEDICAL PERSONNEL, AND APPROPRIATING FUNDS
THEREFOR

*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

1 SECTION 1. The Dinaig Municipal Hospital in the Municipality
2 of Datu Odin Sinsuat, Province of Maguindanao, is hereby
3 converted into a fifty (50)-bed capacity district hospital to be now
4 known as the Datu Odin Sinsuat District Hospital.

5 SEC. 2. The existing hospital facilities and professional health
6 care services of the Datu Odin Sinsuat District Hospital are hereby
7 upgraded and increased commensurate to the increase in bed
8 capacity. The Department of Health, in coordination with the

1 Department of Budget and Management and the Civil Service
2 Commission, shall determine the additional positions to be created
3 pursuant to this Act.

4 SEC. 3. The Provincial Government of Maguindanao shall
5 continue to provide funding for the Datu Odin Sinsuat District
6 Hospital. The Secretary of Health shall include in the Department's
7 subsidy program, support for the capital outlay requirements of the
8 said district hospital.

9 SEC. 4. This Act shall take effect fifteen (15) days after its
10 publication in the *Official Gazette* or in any newspaper of general
11 circulation.
