

AN ACT ESTABLISHING AN ELEMENTARY SCHOOL IN SITIO CABAGAAYAN, BARANGAY SIBULAN, TORIL DISTRICT, DAVAO CITY TO BE KNOWN AS THE CABAGAAYAN ELEMENTARY SCHOOL AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. There is hereby established, under the supervision of the Department of Education, an elementary school

in Sitio Cabagaayan, Barangay Sibulan, Toril District, Davao City

to be known as the Cabagaayan Elementary School.

5 SEC. 2. The Secretary of Education shall immediately include

in the Department's program the operationalization of Cabagaayan

7 Elementary School, the funding of which shall be included in the

8 annual General Appropriations Act.

9 SEC. 3. The Secretary of the Department of Education shall
