

AN ACT SEPARATING THE MALABON NATIONAL HIGH SCHOOL (MNHS) – CONCEPCION TECHNICAL – VOCATIONAL ANNEX IN BARANGAY CONCEPCION, CITY OF MALABON, METRO MANILA FROM THE MALABON NATIONAL HIGH SCHOOL, CONVERTING IT INTO AN INDEPENDENT NATIONAL HIGH SCHOOL TO BE KNOWN AS CONCEPCION TECHNICAL – VOCATIONAL SCHOOL AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. The Malabon National High School (MNHS) –
2 Concepcion Technical – Vocational Annex in Barangay Concepcion,
3 City of Malabon, Metro Manila is hereby separated from the
4 Malabon National High School and converted into an independent
5 national high school to be known as Concepcion Technical –
6 Vocational School.

7 SEC. 2. All personnel, assets, liabilities and records of the
8 Malabon National High School (MNHS) – Concepcion Technical –

1 Vocational Annex are hereby transferred to and absorbed by the
2 Concepcion Technical – Vocational School.

3 SEC. 3. The Secretary of Education shall immediately include
4 in the Department's program the operationalization of the
5 Concepcion Technical – Vocational School, the initial funding of
6 which shall be charged against the current year's appropriation of
7 the Malabon National High School (MNHS) – Concepcion Technical
8 – Vocational Annex. Thereafter, the amount necessary for the
9 continued operation of the school shall be included in the annual
10 General Appropriations Act.

11 SEC. 4. The Secretary of Education shall formulate the rules
12 and regulations necessary to carry out the purpose of this Act
13 within one hundred twenty (120) days after its effectivity.

14 SEC. 5 This Act shall take effect fifteen (15) days after its
15 publication in the *Official Gazette* or in a newspaper of general
16 circulation.
