AN ACT CONVERTING INTO AN INDEPENDENT NATIONAL HIGH SCHOOL TO BE KNOWN AS THE CURRIMAO NATIONAL HIGH SCHOOL THE CURRIMAO NATIONAL HIGH SCHOOL - PIAS-GAANG CAMPUS IN BARANGAY PIAS NORTE, MUNICIPALITY OF CURRIMAO, PROVINCE OF ILOCOS NORTE, AND SEPARATING IT FROM ITS MOTHER SCHOOL, THE CURRIMAO NATIONAL HIGH SCHOOL IN BARANGAY POBLACION 2, MUNICIPALITY OF CURRIMAO, PROVINCE OF ILOCOS NORTE, HEREINAFTER RENAMED THE WILBUR C. GO NATIONAL HIGH SCHOOL, AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

- 1 SECTION 1. The Currimao National High School - Pias-
- 2 Gaang Campus in Barangay Pias Norte, Municipality of Currimao,
- 3 Province of Ilocos Norte is hereby converted into an independent
- 4 national high school to be now known as the Currimao National
- 5 High School, and separated from its mother school, the Currimao
- 6 National High School situated in Barangay Poblacion 2,
- 7 Municipality of Currimao, Province of Ilocos Norte.

1 The mother school situated in Barangay Poblacion 2,
2 Municipality of Currimao, Province of Ilocos Norte shall henceforth
3 be known as the Wilbur C. Go National High School.

4 SEC. 2. All personnel, assets, liabilities and records of the
5 Currimao National High School – Pias-Gaang Campus in Barangay
6 Pias Norte, Municipality of Currimao, Province of Ilocos Norte are
7 hereby transferred to and absorbed by the newly converted national
8 high school, now known as the Currimao National High School.

9 SEC. 3. The Secretary of Education shall immediately
10 include in the Department's program the operationalization of the
11 newly converted national high school, now known as the Currimao
12 National High School. The current year's appropriation of the
13 mother school situated in Barangay Poblacion 2, Municipality of
14 Currimao, Province of Ilocos Norte shall be absorbed by and remain
15 with the now renamed Wilbur C. Go National High School.
16 Thereafter, the amount necessary for the continued operation of
17 both the Currimao National High School and the Wilbur C. Go
18 National High School shall be included in the annual General
19 Appropriations Act.

20 SEC. 4. The Secretary of Education shall issue the rules and
21 regulations necessary to carry out the purpose of this Act within
22 one hundred twenty (120) days after its effectivity.

23 SEC. 5. This Act shall take effect fifteen (15) days after
24 its publication in the *Official Gazette* or in a newspaper of
25 general circulation.
