

SECTION 1. There is hereby established, under	the
supervision of the Department of Education, a national h	igh
school in Barangay Ambiong, Municipality of La Trinid	ad,
Province of Benguet to be known as Ambiong Nation	nal
High School.	
SEC. 2. The Secretary of Education shall immediately inclu	ıde
in the Department's program the operationalization of the Ambio	ng
National High School, the funding of which shall be included in	the
annual General Appropriations Act.	
SEC. 3. The Secretary of Education shall formulate the ru	les
and regulations implementing the provisions of this Act.	
SEC. 4. This Act shall take effect fifteen (15) days after	its
publication in the Official Gazette or in a newspaper of gener	
circulation.
