NATIONAL ESTABLISHING AN INTEGRATED ACT AN SCHOOL IN BARANGAY CAPUY, CITY OF SORSOGON, KNOWN AS SORSOGON TO BEOF **PROVINCE** AND NATIONAL SCHOOL INTEGRATED CAPUY APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

- Section 1. Establishment of an Integrated National School.
- 2 There is hereby established, under the supervision of the
- 3 Department of Education, an integrated national school in
- 4 Barangay Capuy, City of Sorsogon, Province of Sorsogon to be
- 5 known as Capuy Integrated National School.
- 6 SEC. 2. Appropriations. The Secretary of Education shall
- 7 immediately include in the Department's program the
- 8 operationalization of the Capuy Integrated National School, the
- 9 funding of which shall be included in the annual General
- 10 Appropriations Act.
- 11 SEC. 3. Implementation. The Secretary of Education shall
- 12 issue such rules and regulations as may be necessary to carry out
- 13 the purpose of this Act.

SEC. 4. Effectivity. - This Act shall take effect fifteen (15)

2 days after its publication in the Official Gazette. Approved,
