AN ACT ESTABLISHING A NATIONAL HIGH SCHOOL IN BARANGAY ALAMBRE, TORIL DISTRICT, DAVAO CITY TO BE KNOWN AS ALAMBRE NATIONAL AGRICULTURAL HIGH SCHOOL, AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. There is hereby established, under the supervision of the Department of Education, a national high school 2 in Barangay Alambre, Toril District. Davao City to be known as 3 Alambre National Agricultural High School. 4

SEC. 2. The Secretary of Education shall immediately include 5 in the Department's program the operationalization of the Alambre 6 National Agricultural High School, the funding of which shall be 7 included in the annual General Appropriations Act. 8

SEC. 3. The Secretary of Education shall formulate the rules and regulations implementing the provisions of this Act within one 10 hundred twenty (120) days after its effectivity. 11
