

- AN ACT CREATING AN ADDITIONAL BRANCH OF THE REGIONAL TRIAL COURT IN THE PROVINCE OF MOUNTAIN PROVINCE TO BE STATIONED IN THE MUNICIPALITY OF PARACELIS, AMENDING FOR THE PURPOSE SECTION 14, PARAGRAPH (A) OF BATAS PAMBANSA BLG. 129, OTHERWISE KNOWN AS "THE JUDICIARY REORGANIZATION ACT OF 1980", AS AMENDED, AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. An additional branch of the Regional Trial Court
 to be stationed in the Municipality of Paracelis is hereby created in
 the First Judicial Region.

4 The Supreme Court shall assign the branch number of the 5 newly created Regional Trial Court branch in the First Judicial 6 Region. 1 SEC. 2. The Chief Justice of the Supreme Court, in 2 coordination with the Secretary of the Department of Justice, shall 3 immediately include in the Court's program the operationalization 4 of the additional branch of the Regional Trial Court to be stationed 5 in the Municipality of Paracelis, the funding of which shall be 6 included in the annual General Appropriations Act.

SEC. 3. Section 14(a) of Batas Pambansa Blg. 129, otherwise
known as "The Judiciary Reorganization Act of 1980", as amended,
and all other laws, rules and regulations which are inconsistent
with this Act are hereby amended, repealed or modified accordingly.

11 SEC. 4. This Act shall take effect fifteen (15) days after its 12 publication in the *Official Gazette* or in at least two (2) national 13 newspapers of general circulation.
