AN ACT CREATING A BARANGAY IN THE CITY OF DASMARIÑAS, PROVINCE OF CAVITE TO BE KNOWN AS BARANGAY VICTORIA REYES

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. There is hereby created a barangay in the City of Į Dasmariñas, Province of Cavite to be known as Barangay Victoria 2 3 Reves.

SEC. 3. The plebiscite conducted and supervised by the 9 Commission on Elections (COMELEC) pursuant to Provincial 10 Ordinance No. 2000-004 of the Sangguniang Panlalawigan of the 11 Province of Cavite, which ratified the creation of Barangay Victoria 12 Reyes as proclaimed by the Plebiscite Board of Canvassers on 13 October 19, 2003 shall serve as substantial compliance with the 14 requirement under Section 10 of Republic Act No. 7160, otherwise 15 known as the "Local Government Code of 1991", as amended. 16

SEC. 4. The incumbent elected barangay officials of Barangay
Victoria Reyes shall continue to hold office until their successors
shall have been elected and qualified.

20 SEC. 5. All public infrastructure and facilities existing 21 therein at the time of the approval of this Act are hereby 22 transferred without cost or compensation to and shall be 23 administered by the new Barangay Victoria Reyes.

SEC. 6. Barangay Victoria Reyes shall be entitled to the internal revenue allotment (IRA) share pursuant to Section 285 of the Local Government Code of 1991, as amended.

1 SEC. 7. This Act shall take effect fifteen (15) days after its 2 publication in the *Official Gazette* or in a newspaper of general 3 circulation.
