





AN ACT CONVERTING THE MIDSAYAP EXTENSION OFFICE OF THE LAND TRANSPORTATION OFFICE (LTO) LOCATED IN MIDSAYAP, NORTH COTABATO INTO A REGULAR LTO DISTRICT OFFICE AND APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:*

- 1           SECTION 1. The Midsayap Extension Office of the Land  
2           Transportation Office (LTO) located in Midsayap, North Cotabato is  
3           hereby converted into a regular LTO district office and thereafter  
4           shall be referred to as the Midsayap LTO District Office.
- 5           SEC. 2. The Secretary of Transportation shall immediately  
6           include in the Department's program the operationalization of the  
7           Midsayap LTO District Office, the initial funding of which shall be  
8           charged against the current year's appropriations of the existing  
9           Midsayap LTO Extension Office in Midsayap, North Cotabato.  
10          Thereafter, such sums as may be necessary for the continued

1 operation of the Midsayap LTO District Office shall be included in  
2 the annual General Appropriations Act.

3 SEC. 3. The Secretary of Transportation shall issue the  
4 necessary rules and regulations for the effective implementation of  
5 this Act.

6 SEC. 4. This Act shall take effect fifteen (15) days after its  
7 publication in the *Official Gazette* or in a newspaper of general  
8 circulation.

Approved.
