





THEREFOR

*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

1 SECTION 1. There shall be established, under the direct
2 supervision of the Land Transportation Office (LTO) Main Office in
3 Quezon City, a district office in the 2nd District of Cagayan de Oro
4 City.

5 SEC. 2. The Secretary of Transportation shall immediately
6 include in the Department's program the operationalization of
7 the LTO District Office in the 2nd District of Cagayan de Oro City,
8 the funding of which shall be included in the annual General
9 Appropriations Act

10 SEC. 3. This Act shall take effect fifteen (15) days following
11 the completion of its publication in the *Official Gazette* or in two (2)
12 national newspapers of general circulation.
