

AN ACT ESTABLISHING A REGULAR DISTRICT OFFICE OF
THE LAND TRANSPORTATION OFFICE (LTO) IN THE
MUNICIPALITY OF MORONG, PROVINCE OF RIZAL
AND APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

1 SECTION 1. There shall be established a regular district office
2 of the Land Transportation Office (LTO) in the Municipality of
3 Morong, Province of Rizal.

4 SEC. 2. The Secretary of Transportation shall immediately
5 include in the Department's program the operationalization of the
6 LTO District Office in the Municipality of Morong, Province of Rizal,
7 the funding of which shall be included in the annual General
8 Appropriations Act.

9 SEC. 3. This Act shall take effect fifteen (15) days after its
10 publication in the *Official Gazette* or in a newspaper of general
11 circulation.
