AN ACT ESTABLISHING A REGULAR DISTRICT OFFICE OF
THE LAND TRANSPORTATION OFFICE (LTO) IN THE
CITY OF TANAUAN, 3RD DISTRICT OF BATANGAS AND
APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

1 SECTION 1. There shall be established a regular district office
2 of the Land Transportation Office (LTO) in the City of Tanauan,
3 Province of Batangas to serve the City of Tanauan and the
4 municipalities in the 3rd District of Batangas.

5 SEC. 2. The Secretary of Transportation shall immediately
6 include in the Department's programs the operationalization of the
7 LTO Regular District Office in the City of Tanauan, Province of
8 Batangas, the funding of which shall be included in the annual
9 General Appropriations Act.

10 SEC. 3. This Act shall take effect fifteen (15) days after its
11 publication in the *Official Gazette* or in a newspaper of general
12 circulation.
