AN ACT ESTABLISHING A SATELLITE OFFICE OF THE  
LAND TRANSPORTATION OFFICE (LTO) IN THE  
MUNICIPALITY OF GUMBA, PROVINCE OF NUEVA  
ECIJA AND APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the  
Philippines in Congress assembled:*

1 SECTION 1. There shall be established a satellite office of the  
2 Land Transportation Office (LTO) in the Municipality of Guimba,  
3 Province of Nueva Ecija to be known as the Guimba Land  
4 Transportation Satellite Office.

5 SEC. 2. The Secretary of Transportation shall immediately  
6 include in the Department's programs the operationalization of the  
7 LTO Satellite Office in the Municipality of Guimba, Province of  
8 Nueva Ecija, the funding of which shall be included in the annual  
9 General Appropriations Act.

10 SEC. 3. This Act shall take effect fifteen (15) days after its  
11 publication in the *Official Gazette* or in a newspaper of general  
12 circulation.
