



AN ACT ESTABLISHING A SATELLITE OFFICE OF THE
LAND TRANSPORTATION OFFICE (LTO) IN SAN JOSE
DEL MONTE CITY, PROVINCE OF BULACAN AND
APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

1 SECTION 1. There is hereby established a satellite office of
2 the Land Transportation Office (LTO) in the City of San Jose Del
3 Monte, Province of Bulacan.

4 SEC. 2. The Secretary of Transportation shall immediately
5 include in the Department's program the operationalization of the
6 LTO Satellite Office in San Jose Del Monte City in the Province of
7 Bulacan, the funding of which shall be included in the annual
8 General Appropriations Act.

9 SEC. 3. This Act shall take effect fifteen (15) days after its
10 publication in the *Official Gazette* or in a newspaper of general
11 circulation.
