AN ACT ESTABLISHING A REGULAR DISTRICT OFFICE
OF THE LAND TRANSPORTATION OFFICE (LTO)
IN THE MUNICIPALITY OF RONDA IN THE 7TH
DISTRICT OF THE PROVINCE OF CEBU AND
APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

1 SECTION 1. There is hereby established a regular district
2 office of the Land Transportation Office (LTO) to be located in the
3 Municipality of Ronda in the 7th District of the Province of Cebu.

4 SEC. 2. The Secretary of Transportation shall immediately
5 include in the Department's program the operationalization of the
6 LTO Regular District Office in the Municipality of Ronda in the 7th
7 District of the Province of Cebu, the funding of which shall be
8 included in the annual General Appropriations Act.

9 SEC. 3. This Act shall take effect fifteen (15) days after its
10 publication in the *Official Gazette* or in a newspaper of general
11 circulation.
