AN ACT SEPARATING THE CITY OF SANTA ROSA FROM THE FIRST
LEGISLATIVE DISTRICT OF THE PROVINCE OF LAGUNA TO
CONSTITUTE THE LONE LEGISLATIVE DISTRICT OF THE
CITY OF SANTA ROSA

*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

1 SECTION 1. *Lone Legislative District.* – The City of Santa
2 Rosa is hereby separated from the First Legislative District of the
3 Province of Laguna to constitute the Lone Legislative District of the
4 City of Santa Rosa, which shall commence in the next national and
5 local elections after the effectivity of this Act.

6 SEC. 2. *Incumbent Representative.* – The incumbent
7 Representative of the First Legislative District of the Province of
8 Laguna shall continue to represent the said district until the new
9 Representative of the Lone Legislative District of the City of Santa
10 Rosa shall have been elected and qualified.

11 SEC. 3. *Rules and Regulations.* – Within sixty (60) days
12 from the effectivity of this Act, the Commission on Elections shall
13 issue the necessary rules and regulations to implement the
14 provisions of this Act.

1 SEC. 4. *Repealing Clause.* — Section 59 of Republic Act
2 No. 9264, otherwise known as the “Charter of the City of Santa
3 Rosa”, and all other laws, rules and regulations, which are
4 inconsistent with this Act, are hereby repealed, amended or
5 modified accordingly.

6 SEC. 5. *Effectivity.* — This Act shall take effect fifteen (15)
7 days after its publication in the *Official Gazette* or in a newspaper of
8 general circulation.
