



AN ACT CONVERTING THE LAND TRANSPORTATION
OFFICE (LTO) EXTENSION OFFICE LOCATED IN
THE MUNICIPALITY OF ROSALES, PROVINCE OF
PANGASINAN INTO A REGULAR LTO DISTRICT
OFFICE AND APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

1 SECTION 1. The existing Land Transportation Office (LTO)
2 Extension Office located in the Municipality of Rosales, Province of
3 Pangasinan, is hereby converted into a regular LTO district office to
4 be known as the LTO-Rosales District Office.

5 SEC. 2. The Secretary of Transportation shall immediately
6 include in the Department's program the operationalization of the
7 LTO-Rosales District Office, the initial funding of which shall be
8 charged against the current year's appropriation of the LTO-Rosales
9 Extension Office. Thereafter, such sums as may be necessary for the
10 continued operation of the LTO-Rosales District Office shall be
11 included in the annual General Appropriations Act.
