Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. The existing Land Transportation Office (LTO)
Extension Office located in Cauayan City, Province of Isabela, is
hereby converted into a regular LTO district office to be known as
the LTO-Cauayan City District Office.

5 SEC. 2. The Secretary of Transportation shall immediately include in the Department's program the operationalization of the 6 7 LTO-Cauayan City District Office in the Province of Isabela, the 8 initial funding of which shall be charged against the current year's 9 appropriation of the LTO-Cauayan City Extension Office. Thereafter, such sums as may be necessary for the continued 10 operation of the LTO-Cauayan City District Office shall be included 11 12 in the annual General Appropriations Act.
