



MUNICIPALITY OF MINA, PROVINCE OF ILOILO, IN
COMMEMORATION OF ITS FOUNDING DAY

*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

1 SECTION 1. September 9 of every year is hereby declared a
2 special nonworking holiday in the Municipality of Mina, Province of
3 Iloilo, in commemoration of its founding day.

4 SEC. 2 This Act shall take effect fifteen (15) days after its
5 publication in the *Official Gazette* or in a newspaper of general
6 circulation.
