AN ACT  
ESTABLISHING THE PHILIPPINE AIR FORCE ACADEMY (PAFA)  
AND APPROPRIATING FUNDS THEREFOR

EXPLANATORY NOTE

The improvement of the Philippine Air Force's (PAF) regular officer delivery system has been an impending need of the military establishment.

The PAF Flying Schools (PAFFS), which is at present the main source of regular officers in the PAF, could no longer provide the required number and proper training of officer pilots because of inadequate facilities and logistical support.

More so, since a college degree is an academic requirement for entrance into the PAFFS, thousands of poor high school graduates with great potentials are denied from joining the PAF because they have no financial support for a college education.

The creation of the Philippine Air Force Academy (PAFA) shall address this problem in line with the constitutional mandate of guaranteeing equal access of opportunity for public service.

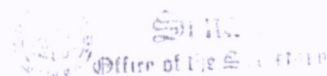
Given the inherent political instability of a developing country such as the Philippines, we should ensure that our systems do not espouse an unwanted relationship among officers often called "regular officer homogeneity". Concerned sectors believed that this "officer homogeneity" may endanger a potentially explosive political situation where all the branches and levels of the Armed Forces are controlled by a regular-officer school. The creation of the PAF will help preclude this situation.

There is also a need to professionalize other officer career areas of the Air Force such as the aircraft maintenance, avionics and air logistics to further

The PAF Academy as conceptualized, is geared towards making available an adequate and dedicated corps of professional Air Force officers with the proper education, training and orientation to lead and manage the complex technologies inherent in the field of aviation.

For these foregoing reasons, the approval of this bill is earnestly requested.

AN ACT  
ESTABLISHING THE PHILIPPINE AIR FORCE ACADEMY (PAFA) AND  
APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in Congress Assembled:*

1           **SECTION 1. *Philippine Air Force Academy*** - There shall be established in the  
2 Philippine Air Force an educational institution to be known as the Philippine Air Force  
3 Academy (PAFA), hereinafter referred to as the Academy, for the instruction and  
4 preparation for military service of Air Force Cadets.

5  
6           **SECTION 2 *Administration*** - The academy as herein established shall be  
7 organized and administered by the Commanding General Philippine Air Force (PAF)  
8 under the general supervision and control of the Chief of Staff of the Armed Forces of  
9 the Philippines.

10  
11           **SECTION 3. *Academic Board*** - The Academic Board of the Academy shall be  
12 composed of the Superintendent, the Dean of the Corps of Professors, the  
13 Commandant of Cadets and the Heads of the departments to be constituted as follows:

- 14  
15           a) The Superintendent and the Commandant of Cadets of the Academy shall  
16 be detailed to those positions by the President from the Officers of the Air  
17 Force.  
18           b) The Dean of the Corps of Professors shall be appointed from the permanent  
19 professors who have served as heads of departments of instructions at the  
20 Academy.



- 1 c) The Academic Board shall have the power to confer the degree of Bachelor  
2 of Science under the rules and regulations as the Chief of Staff of the  
3 Armed Forces of the Philippines may prescribe upon all cadets who may  
4 hereafter satisfactorily complete the approved course of studies.  
5

6 **SECTION 4. *Department Title and Faculty*** - The Chief of Staff of the Armed  
7 Forces of the Philippines may prescribe the title of each of the departments of  
8 instruction and professors of the Academy. However, each change of the title of the  
9 department or professor shall not affect the status, rank or eligibility for promotion or  
10 retirement of, or otherwise prejudice, a professor of the Academy.  
11

12 **SECTION 5. *Cadet Corps of the Philippine Air Force*** - The student body of  
13 the Academy shall be known as the Cadet Corps of the Philippine Air Force (CCPAF).  
14 The President is authorized to appoint annually, subject to such physical and mental  
15 examinations as may be prescribed, the number of cadets necessary to maintain the  
16 Cadet Corps at a strength as may be determined by the Academic Board.  
17

18 The Academy shall provide for educational and physical facilities for the  
19 recruitment and training of women as member of Cadet Corps.  
20

21 All cadets shall be appointed by the President. An appointment is conditional  
22 until the cadet is admitted.  
23

24 **SECTION 6. *Eligibility for Admission*** - To be eligible for admission, a  
25 candidate must be:

- 26 1) Single  
27 2) A natural born citizen of the Philippines;  
28 3) At least seventeen (17) years of age but not more than twenty two (22) years  
29 of age on the first day of April of the year of admission;  
30 4) At least high school graduate;  
31 5) A successful examinee of the prescribed physical and mental examination;  
32 and  
33 6) A successful examinee of the National Secondary Assessment Test.  
34

1           **SECTION 7. *Pay and Allowances*** - The pay and allowances of the Cadets of  
2 the Academy shall be fixed by the President.

3  
4           **SECTION 8. *Undertaking*** - Each cadet shall sign an agreement that unless  
5 sooner separated by duly authorized, authority, he shall

7           1) Complete the course of instruction at the Academy;  
8           2) Accept an appointment and serve as a commissioned officer of the  
9 Armed Forces of the Philippines for at least eight years immediately after  
10 graduation from the Academy.

11  
12           **SECTION 9. *Cadet requirement*** - Any Cadet who shall after entrance to the  
13 Academy and before completion of the prescribed courses of training, be found  
14 physically and mentally unfit for military assignment by reason of injury or disease  
15 incident to the service, shall be retired with the rank of second lieutenant of the Armed  
16 Forces of the Philippines.

17  
18           **SECTION 10. *Prohibition Against Hazing*** - Subject to the approval of the  
19 Secretary of the National Defense, the Superintendent of the Academy shall issue rules  
20 and regulations preventing hazing and prescribe dismissal suspension and other  
21 adequate punishment for violation thereof.

22  
23           For the purpose of this Act "hazing" means any unauthorized assumption of  
24 authority by a cadet whereby another cadet suffers or is exposed to any form of injury,  
25 indignity, humiliation, hardship or oppression or the deprivation or abridgement of any  
26 right.

27  
28           If a cadet is charged with violating any rule or regulation issued pursuant to this  
29 section, the penalty of which is dismissal from the Academy, a request in writing for a  
30 trial by a general court martial may be submitted.

31  
32           A cadet dismissed from the Academy for hazing shall not be reappointed as an  
33 Air Force Cadet and shall be ineligible for appointment as a commissioned officer in  
34 the Armed Forces of the Philippines unit after two (2) years from the graduation of the  
35 class.

1           **SECTION 11. *Commission*** - Upon satisfactory completion of the course of  
2 instruction at the Academy, the Cadets shall be commissioned second lieutenants in  
3 the regular force of the Philippine Air Force with the relative rank in the order of final  
4 general standing as determined by the Academic Board of the Academy and approved  
5 by the Chief of Staff of the Armed Forces of the Philippines.  
6

7           **SECTION 12. *Transfer of Assets and Liabilities*** - The Philippine Air Force  
8 Flying School, including the members of its faculty and personnel, its records,  
9 equipment, assets and liabilities are hereby transferred to and integrated with the  
10 Philippine Air Force Academy.  
11

12           **SECTION 13. *Budget*** - The initial appropriations necessary for the  
13 establishment of the Academy shall be charged to the appropriation of the Department  
14 of National Defense. Thereafter, the amount necessary for the improvement, operation  
15 and maintenance of the Academy shall be included in the Annual General  
16 Appropriations Act.  
17

18           **SECTION 14. *Effectivity*** - This Act shall take effect upon approval.
