

**AN ACT**  
**INSTITUTIONALIZING THE "ABOT ALAM" PROGRAM OF THE DEPARTMENT OF EDUCATION, APPROPRIATING FUNDS THEREFOR, AND FOR OTHER PURPOSES**

*Explanatory Note*


Article XIV, Section 1 of the 1987 Constitution provides that "The State shall protect and promote the right of all citizens to quality education at all levels, and shall take appropriate steps to make such education accessible to all." This Constitutional mandate includes the improvement of our formal education system to catch those who fall between the cracks- the out-of-school youths and adults who neither underwent nor completed basic education.

As a first step, the Department of Education created the "Abot Alam" program. According to DepEd, Abot-Alam is a convergence program that is being undertaken by a consortium of various national government agencies, and non-government organizations (NGOs) and institutions under the leadership of DepEd and the National Youth Commission (NYC) to locate and serve out-of-school youth (OSY) nationwide and who have not completed basic/higher education or who are unemployed.

This measure seeks to institutionalize the "Abot Alam" program and expand it to include adults who have neither undergone nor completed basic education. It also establishes a Barangay Abot Alam Targeting System to collect information and monitor all out-of-school youths. Finally, it prescribes the various modalities of the Abot Alam Program.

Speedy approval of this measure is eagerly sought.

**AN ACT**  
**INSTITUTIONALIZING THE "ABOT ALAM" PROGRAM OF THE DEPARTMENT OF EDUCATION, APPROPRIATING FUNDS THEREFOR, AND FOR OTHER PURPOSES**

*Be it enacted by the Senate and the House of Representatives of the Philippines in Congress Assembled:*

1 Section. 1. *Short Title.* – This Act shall be known as the "Abot Alam Act of  
2 2019"

3 Sec. 2. *Declaration of Policy.* – It is a policy of the State to protect and  
4 promote the right of all citizens, especially the poor and the marginalized, to quality  
5 education at all levels. Furthermore, the State recognizes the essential role of  
6 education in promoting a just and dynamic social order that will ensure the  
7 prosperity and independence of the nation and free the people from poverty.  
8 Therefore, the "Abot Alam" program of the Department of Education is hereby  
9 institutionalized and recognized as a means to provide education to out-of-school  
10 youths, adults who have neither undergone nor completed basic education, and to  
11 other individuals who cannot be adequately served by the formal educational  
12 system.

13 Sec. 3. *Definition of Terms.* – As used in this Act, the following terms shall be  
14 defined as follows:

15 (a) *Abot Alam* - refers to the "Abot Alam" program of the Department of  
16 Education which is institutionalized under Section 4 of this Act;

17 (b) *Abot Alam Enlisted Learners* or *Enlisted Learners* - refers to individuals,  
18 whether out-of-school youths or adults who have neither undergone nor

1 completed basic education, who are enrolled in any of the components of  
2 the Abot Alam Program.

3 (c) *Abot Alam Partner or Partners* - refers to individuals, groups, organizations  
4 or agencies (e.g. LGUs, NGOs, private institutions/companies, religious  
5 groups, etc.) implementing the Abot Alam Program in different areas using  
6 their own resources and/or which provide technical assistance or other  
7 resources in support of the Program at any level;

8 (d) *Barangay Abot Alam Targeting System or Targeting System* refers to the  
9 comprehensive database of OSY established under Section 5 of this Act.

10 (e) *Alternative Delivery Modes* - as defined and adopted from Department of  
11 Education Order No. 54, s. 2012, refers to alternative modalities of  
12 delivering education which allows schools to deliver quality education to  
13 marginalized students and those at risk of dropping out in order to help  
14 them overcome personal, social and economic constraints in their  
15 schooling. It shall include, without limitation, the following:

- 16 1. Enhanced Instructional Management Parents, Communities and  
17 Teachers (E-IMPACT);
- 18 2. Modified In-School Off-School Approach (MISOSA); and
- 19 3. Open High School Program (OHSP)

20 (f) *Alternative Learning System* - as defined and adopted from Republic Act  
21 No. 9155, otherwise known as the Governance of Basic Education Act of  
22 2001, is a parallel learning system to provide a viable alternative to the  
23 existing formal education instruction. It encompasses both the non-formal  
24 and informal sources of knowledge and skills;

25 (g) *Out-of-School Youth or OSY* - refers to individuals who are 7 to 24 years  
26 of age who are not enrolled in formal schooling.

27 *Sec. 4. Institutionalization of the Abot Alam Program.* – there is hereby  
28 established a nationwide program to be known as the “Abot Alam” Program, herein  
29 referred to as “the Program”.

30 *Sec. 5. Objectives.* – The Program aims to:

31 (a) Create a comprehensive database of OSY in the country by organizing a  
32 Barangay Abot Alam Targeting System;

1 (b) Unify and harmonize the efforts and resources of all agencies and  
2 organizations directed towards providing education and training for OSY in  
3 the Country;

4 (c) Ensure that all OSYs have access to programs and services of different  
5 agencies and organizations;

6 (d) Integrate adults who have neither undergone nor completed formal  
7 education in the Program;

8 *Sec. 6. Coverage.* the Act shall cover:

9 (a) Out-of-School Youths;

10 (b) Marginalized students who are at risk of dropping out; and

11 (c) Adults who have neither undergone nor finished basic education.

12 *Sec. 7. Barangay Abot Alam Targeting System.* – A comprehensive database  
13 of OSYs in the country is hereby established. The targeting system shall be based  
14 on information collected and updated by Barangays on OSYs in their jurisdiction, in  
15 coordination with the relevant Public Schools District Supervisors and School Heads.  
16 The database shall be updated annually and shall include information such as one's  
17 name, age, location, and learning needs. All information shall be submitted to and  
18 consolidated by the Philippine Statistics Authority. Existing enrollees of the Program  
19 need not be included in the database.

20 *Sec. 8. Components.* – The Program shall have three (3) modalities:

21 (a) ALS-Education - a community-based ALS program which helps Enlisted  
22 Learners to acquire basic reading, writing, numeracy skills and the ability  
23 to read with comprehension and solve simple numeracy problems. Enlisted  
24 Learners under this program shall undergo an accreditation and  
25 equivalency test before and after the program duration which will  
26 measures their learning competency. Passers of the test are shall be given  
27 a diploma certifying their competencies as comparable graduates of the  
28 formal school system and shall be considered qualified to enroll secondary  
29 and post-secondary schools. This program shall be implemented by the  
30 Department of Education, in coordination with interested Partners.

31 (b) ALS-Entrepreneurship - an ALS program which provides livelihood and  
32 entrepreneurship training and assistance to Enlisted Learners. This shall

1 be a joint program of the Department of Education and Department of  
2 Trade and Industry, in coordination with interested Partners.

3 (c) ALS Technical-Vocational and Employment Program - an ALS program  
4 which provides technical-vocational skills training to Enlisted Learners. This  
5 shall be a joint program of the Department of Education and Technical  
6 and Vocational Education and Skills Development Authority in coordination  
7 with interested Partners.

8 *Sec. 9. Utilization of Alternative Delivery Modes.* – The Department of  
9 Education and concerned Partners shall, in addition to formal, school-based modes  
10 of delivering education, shall maximize the utilization of Alternative Delivery Modes  
11 of education.

12 *Sec. 10. Program Implementation.* – DepEd Division Offices, in consultation  
13 with all concerned Partners, shall map and provide information on all of the ALS  
14 programs of intervention that they are offering in their jurisdiction and match the  
15 needs of Enlisted Learners with the available programs mapped;

16 *Sec. 11. Implementing Rules and Regulations.* – Within thirty (30) days from  
17 the effectivity of this Act, the Department of Education, Technical Education and  
18 Skills Development Authority, and the Department of Trade and Industry, in  
19 consultation with relevant government agencies and partners, shall promulgate the  
20 rules and regulations for the effective regulation of this Act.

21 *Sec. 12. Appropriations.* – An amount of Ten Million Pesos (Php  
22 10,000,000.00) is hereby allocated for the initial implementation of this act. Such  
23 amounts as may be necessary for the continuing implementation of this Act shall be  
24 included as a separate line-item under the appropriations of the Department of  
25 Education under the General Appropriations Act and may be augmented by grants,  
26 donations and endowments from domestic and foreign sources, pursuant to existing  
27 laws and regulations.

28 *Sec. 13. Separability Clause.* – If any provision of this Act shall be held  
29 unconstitutional or invalid, the other provisions not otherwise affected shall remain  
30 in full force and effect.

1           Sec. 14. *Repealing Clause.* – All laws, executive orders, rules and regulations  
2 inconsistent with or contrary to this Act, are hereby deemed accordingly repealed or  
3 amended.

4           Sec. 15. *Effectivity Clause.* – This Act shall take effect upon its approval and  
5 completion of publication in at least two (2) national newspapers of general  
6 circulation.
