

### AN ACT

## STRENGTHENING THE DRUG REHABILITATION PROGRAMS OF THE GOVERNMENT, AMENDING FOR THIS PURPOSE REPUBLIC ACT NO. 9165 OTHERWISE KNOWN AS THE "COMPREHENSIVE DANGEROUS DRUGS ACT OF 2002", AS AMENDED, APPROPRIATING FUNDS THEREOF, AND FOR OTHER PURPOSES.

#### Explanatory Note

As of 9 August 2016, around 1.2 million drug suspects have surrendered as a result of the administration's zero-tolerance policy on illegal drugs.<sup>1</sup> However, the huge volume of drug users who have surrendered has exposed our lack of drug rehabilitation centers. To quote a recent *Manila Bulletin* report: "As the number of drug dependents surrendering to authorities continues to spike, the government is now faced with the problem of where to place them as the number of existing rehabilitation centers cannot accommodate them all at the same time."<sup>2</sup>

The shortage of drug rehabilitation centers is a major problem that merits immediate action. Approaching the illegal drug problem purely through the lens of criminal law and prosecution is not effective. Our criminal and justice systems are reformative in nature. Thus, the construction of additional rehabilitation centers is necessary to ensure that those who have surrendered will not go back to drug use and dependence. We should not only destroy *shabu* laboratories but also reduce the demand for *shabu* through holistic measures.

As a response, this bill seeks to strengthen the drug rehabilitation and treatment program of the government. It seeks to amend Republic Act No. 9165, otherwise known as the "*Comprehensive Dangerous Drugs Act of 2002"*, and introduces the following amendments, among others:

- 1. Establish Department of Health (DOH)-administered drug rehabilitation centers in every province and highly urbanized city in the country, and providing for adequate organization and staffing for such;
- 2. Expand the duties and powers of the DOH with regard to the regulation and administration of drug rehabilitation centers; and
- 3. Create a benefit package for the rehabilitation and detoxification of drug users under the Philippine Health Insurance Corporation.

In order to help the administration's anti-drug campaign, speedy approval of this measure is eagerly sought.

# STRENGTHENING THE DRUG REHABILITATION PROGRAMS OF THE GOVERNMENT, AMENDING FOR THIS PURPOSE REPUBLIC ACT NO. 9165 OTHERWISE KNOWN AS THE "COMPREHENSIVE DANGEROUS DRUGS ACT OF 2002", AS AMENDED, APPROPRIATING FUNDS THEREOF, AND FOR OTHER PURPOSES.

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

- 1 Section 1. Section 75, Article VIII or Republic Act No. 9165 is hereby 2 amended to read as follows:
- "Section 75. Treatment and Rehabilitation Centers. The 3 existing treatment and rehabilitation centers for drug dependents 4 operated and maintained by the NBI and the PNP shall be operated, 5 maintained and managed by the DOH in coordination with other 6 concerned agencies. For the purpose of enlarging the network of 7 centers, the Board through the DOH, shall encourage, promote or 8 whenever feasible, assist or support in the establishment, operations 9 and maintenance of private centers which shall be eligible to receive 10 grants, donations or subsidy from either government or private 11 sources. It shall also support the establishment of government-12 operated regional treatment and rehabilitation centers. [depending 13 upon the availability of funds.] 14
- 15 The national government, through its appropriate agencies shall give 16 priority funding for the increase of subsidy to existing government drug 17 rehabilitation centers, and shall establish at least one (1) **DOH**-

**ADMINISTERED** drug rehabilitation center in each province[7] AND 1 HIGHLY URBANIZED CITY IN THE COUNTRY [depending on the 2 availability of funds] 3 Sec. 2. A new Section 75(A) is hereby inserted under Article VIII of Republic 4 Act No. 9165 and shall read as follows: 5 "SECTION 75-A. FUNCTIONS OF DRUG REHABILITATION 6 CENTERS. - DRUG REHABILITATION CENTERS, WHETHER 7 PRIVATE OR PUBLIC, SHALL HAVE THE FOLLOWING 8 FUNCTIONS: 9 AFFORDABLE, ACCESSIBLE, PROVIDE (A) то 10 EVIDENCE-BASED TREATMENT, ACCOMMODATION, 11 AND GUIDANCE AND COUNSELING SERVICES TO 12 PERSONS FOUND TO BE DRUG USERS; 13 (B) TO ENSURE THAT DRUG USERS WILL NOT GO 14 BACK INTO DRUG USE AND DEPENDENCE; 15 (C) TO EMPOWER DRUG USERS TO REGAIN THEIR 16 AND UNDERSTAND THE SELF-CONFIDENCE 17 NEGATIVE PHYSICAL AND SOCIAL IMPACTS OF 18 SUBSTANCE ABUSE; 19 COMMUNITY INVOLVE FAMILIES AND (D) TO 20 MEMBERS IN THE REHABILITATION OF DRUG USERS 21 SO AS TO FACILITATE THE MENDING OF SOCIAL 22 BONDS WHICH HAVE BEEN DESTROYED DUE TO 23 LONG SUBSTANCE ABUSE AND PROVIDE A SUPPORT 24 BEYOND THE DRUG USERS FOR NETWORK 25 TREATMENT AND REHABILITATION PERIOD; AND 26 TO PROVIDE AFTER-CARE, FOLLOW-UP, AND (E) 27 SOCIAL REINTEGRATION SERVICES TO ENABLE A 28 PREVIOUS DRUG DEPENDENT TO ADJUST TO FAMILY 29 AND COMMUNITY LIFE AFTER HIS RELEASE." 30 31

Sec. 3. A new Section 75(B) is hereby inserted under Article VIII of Republic
Act No. 9165 and shall read as follows:

"SECTION 75(B). ORGANIZATION AND STAFFING- EACH 3 CENTER SHALL BE HEADED BY ONE DIRECTOR TO BE 4 ASSISTED BY AT LEAST THREE (3) ASSISTANT DIRECTORS 5 FOR OUTPATIENT OR INPATIENT CARE, ADMINISTRATION 6 AND FINANCE, DEPENDING ON SERVICE TYPE AND CAPACITY, 7 WHO SHALL ALL BE APPOINTED BY THE SECRETARY OF 8 HEALTH. THE DIRECTOR AND DEPUTY DIRECTORS SHALL 9 HAVE THE GENERAL POWERS EXERCISED BY A CHIEF AND 10 ASSISTANT CHIEFS, RESPECTIVELY, OF A GOVERNMENT 11 HOSPITAL. 12

NO PERSON SHALL BE APPOINTED DIRECTOR OR 13 DEPUTY DIRECTOR UNLESS HE OR SHE IS A CITIZEN AND 14 RESIDENT OF THE PHILIPPINES; A PHYSICIAN OF GOOD 15 STANDING WITH AT LEAST THREE (3) YEARS OF EXPERIENCE 16 IN THE CARE, TREATMENT AND REHABILITATION OF DRUG 17 USERS; AND MUST NOT HAVE BEEN A CANDIDATE FOR ANY 18 ELECTIVE NATIONAL OR LOCAL OFFICE IN THE IMMEDIATELY 19 PRECEDING ELECTIONS, WHETHER REGULAR OR SPECIAL. 20

21THE DOH MAY ISSUE ADITIONAL GUIDELINES ON THE22QUALIFICATIONS OF THE DIRECTORS OF CENTERS PURSUANT23TO SECTION 76 (10) OF THIS ACT.

THE DIRECTOR SHALL APPOINT OTHER STAFF AS MAY BE NECESSARY SUBJECT TO GUIDELINES ISSUED PURSUANT TO ARTICLE VIII, SECTION 76 (10) OF THIS ACT.

THE SALARIES AND EMOLUMENTS OF THE DIRECTORS AND ALL PERSONNEL OF CENTERS SHALL BE IN ACCORDANCE WITH LAWS, AND RULES AND REGULATIONS ON SALARY STANDARDIZATION."

1 Sec. 4. Section 76, Article VIII of Republic Act No. 9165 is hereby amended to 2 read as follows:

"Section 76. The Duties and Responsibilities of the Department 3 of health (DOH) Under this Act. - The DOH shall: 4  $(1) \times \times \times$ 5 XXXX 6 "(7) IDENTIFY THE LOCATION, TYPE AND SERVICE 7 DOH-ADMINISTERED DRUG CAPACITY OF THE 8 REHABILITATION CENTERS TO BE CONSTRUCTED ON A 9 CASE TO CASE BASIS, AFTER PRIOR SUFFICIENT 10 CONCERNED LOCAL CONSULTATION WITH THE 11 GOVERNMENT UNITS AND COMMUNITIES; 12 DEVELOP A WORKFORCE PLAN FOR THE "(8) 13 CONTINUOUS PROVISION OF MEDICAL TOXICOLOGISTS 14 AND OTHER NECESSARY MEDICAL STAFF; 15 "(9) PROVIDE TRAINING AND TECHNICAL ASSISTANCE 16 TO THE STAFF OF DRUG REHABILITATION CENTERS, 17 WHETHER PUBLIC OR PRIVATE; AND 18 ON THE GUIDELINES PROMULGATE **`(10)** 19 DOH-OF AND STAFFING ORGANIZATION 20 CENTERS, IN REHABILITATION ADMINISTERED 21 COORDINATION WITH THE DEPARTMENT OF BUDGET 22 AND OTHER CONCERNED AND MANAGEMENT 23 GOVERNMENT AGENCIES. 24 Sec. 5. A new Section 76(A) is hereby inserted under Article VIII of Republic 25 Act No. 9165 and shall read as follows: 26 76-A. BENEFIT PACKAGE FOR "SECTION 27 **REHABILITATION AND DETOXIFICATION. - THE PHILIPPINE** 28 HEALTH INSURANCE CORPORATION SHALL DESIGN BENEFIT 29 REHABILITATION, TREATMENT AND 30 PACKAGES FOR DETOXIFICATION OF DRUG DEPENDENTS AND SHALL ISSUE 31 **GUIDELINES THEREOF. # (B) SERVICES OF HEALTH CARE PROFESSIONALS; AND

(C) PRESCRPTION DRUGS, SUBJECT TO SECTION 37 OF THIS ACT.

6 Sec. 6. *Appropriations.* –The amount necessary for the initial implementation 7 of this Act shall be charged against the current appropriations of the DOH. 8 Thereafter, such sums as may be necessary for the continued implementation of this 9 Act shall be included in the annual General Appropriations Act.

Grants, donations, and endowments from domestic and foreign sources, pursuant to existing laws and regulations, may be used to augment the sources of funding identified under Article X, Sec. 87 of Republic Act N. 9165. All income generated from the operation of centers shall be retained by the DOH and shall be used to augment the centers' Maintenance and Other Operating Expenditures and Capital Outlay. *Provided,* that the said amount shall not be used or realigned for the payment of salaries, allowances and other benefits.

Sec. 7. *Implementing Rules and Regulations.* – The Department of Health, in consultation with the Dangerous Drugs Board, the Department of Interior and Local Government, the Department of Justice, the Department of Social Welfare and Development, and the Philippine National Police, shall promulgate the rules and regulations for the implementation of this Act no later than thirty (30) days after its effectivity.

23 Sec. 8. *Separability Clause.* – If any provision of this Act shall be held 24 unconstitutional or invalid, the other provisions not otherwise affected shall remain 25 in full force and effect.

Sec. 9. *Repealing Clause.* – All laws, executive orders, rules and regulations inconsistent with or contrary to this Act, are hereby deemed accordingly repealed or amended.

Sec. 10. *Effectivity Clause.* – This Act shall take effect upon its approval and
completion of publication in the Official Gazette.
