CALL TO ORDER

At 3:00 p.m., the Senate President, Hon. Vicente C. Sotto III, called the session to order.

PRAYER

The Body observed a minute of silent prayer.

ROLL CALL

Upon direction of the Senate President, the Secretary of the Senate, Atty. Myra Marie D. Villarica, called the roll, to which the following senators responded:

With 20 senators present, the Chair declared the presence of a quorum.

Senators Gordon and Villar arrived after the roll call.

Senator De Lima was unable to attend the session as she was under detention.

Senator Pangilinan was absent.

DEFERMENT OF APPROVAL OF THE JOURNAL

Upon motion of Senator Zubiri, there being no objection, the Body deferred the consideration of the Journal of Session No. 14 (August 27, 2019) to a later hour.

ACKNOWLEDGMENT OF THE PRESENCE OF GUESTS

At this juncture, Senator Zubiri acknowledged the presence in the gallery of the following guests:

Senate President Sotto welcomed the guests to the Senate.

PARLIAMENTARY INQUIRY OF SENATOR TOLENTINO

Senator Tolentino recalled that before the session was adjourned the previous day, the referral of Senate Bill No. 934 (Free On-Site Living Quarters for Public School Teachers Act) was transferred from the Committee on Basic Education, Arts and Culture to the Committee on Finance and the Committee on Urban Planning, Housing and Resettlement following the suggestion of Senator Drilon.

Seeking a ruling from the Chair, he then inquired whether bills with appropriations impact should be referred to the Committee on Finance as the primary committee in light of Section 15 of the Rules which he quoted, to wit:

"Although a measure covers subject matters falling within the jurisdiction of more than one (1) committee, it shall be referred to not more than two (2) committees: *Provided, however*, That a motion for referral to a third committee shall be referred to the Committee on Rules: *Provided, further*, That measures involving the appropriation of funds or embodying tax or revenue proposals shall be respectively referred also to the Committee on Finance for the appropriations aspect...".

He further inquired whether the action of the Body to refer Senate Bill No. 934 primarily to the Finance Committee was meant to supersede Section 15 which, he noted, is also related to Section 26 which provides that "In case a bill or joint resolution is reported out by a committee which contains an appropriation, revenue or tax aspect, the same shall be referred by the primary committee to the Committee on Finance."

Senate President Sotto explained that it is very seldom that a bill is primarily referred to the Committee on Finance, and that Senate Bill No. 934 was referred to the Committee on Finance only upon the suggestion of Senator Drilon. However, he said that the Body could entertain a motion to refer the bill to another primary committee, with the Committee on Finance as a support committee.

To Senator Tolentino's concern that the arrangement might set a precedent wherein all bills with an appropriation aspect, whether a part, feature or portion of it, would automatically be referred to the Committee on Finance as the primary committee, Senate President Sotto reiterated that referral of such nature seldom happens, noting that it is only the General Appropriations Bill (GAB), once transmitted to the Senate, that is referred to the Committee on Finance as the primary committee.

He again explained that the referral of Senate Bill No. 934 to the Committee on Finance was upon the suggestion of Senator Drilon, and he clarified that said referral did not necessarily supersede the Rules. Thus, he said that the Committee on Finance could be made the secondary committee.

Senator Zubiri stated that if the said bill has a funding requirement, the Committee on Finance would only be the secondary committee as the main subject of the bill is housing for teachers.

Moreover, Senator Zubiri stated that the reason why the bill was initially referred to the Committee on Basic Education, Arts and Culture as the primary committee and to the Committee on Finance as the secondary committee was that it was the same measure that was filed in the Seventeenth Congress and referred to the same committees; thus, the Secretariat deemed it fit to follow the same referral in the present Congress. However, he said that nothing would prevent the Body from reversing such referral as it could be changed anytime.

CHANGE OF COMMITTEE REFERRAL

Thereupon, upon motion of Senator Zubiri, there being no objection, the Body approved the change of referral of Senate Bill No. 934 (*Free On-Site Living Quarters for Public School Teachers Act*) to the Committee on Urban Planning, Housing and Resettlement as the primary committee, and to the Committee on Finance as the secondary committee.

DEFERMENT OF THE REFERENCE OF BUSINESS

Upon motion of Senator Zubiri, there being no objection, the reading of the Reference of Business was deferred to a later hour to give way to the holding of an all-senators' caucus.

SUSPENSION OF SESSION

Upon motion of Senator Zubiri, the session was suspended.

MANIFESTATION OF SENATOR TOLENTINO

Senator Tolentino prefaced his manifestation with a quotation from Lincoln Chafee, to wit: "In the world of diplomacy, some things are better left unsaid."

Senator Tolentino informed the Body that he has received reports that afternoon pertinent to the June 9 incident involving Chinese and Filipino vessels near the Recto Bank that the shipowner of the Chinese vessel had issued an apology through an association — the Association of Guangdong Fish Vessels. He quoted a pertinent provision of the letter which was coursed through the Secretary of Foreign Affairs, to wit: "The shipowner of the Chinese fishing boat involved, through our Association, would like to express his sincere apology to the Filipino fishermen."

Senator Tolentino noted that the apology was issued on the eve of the President's departure for the People's Republic of China and on the eve of the game of the country's basketball team in Guangdong. However, he believed that the country should still pursue its claims for damages, as also mentioned in the apology letter, in order to give justice to the Filipino fishermen.

Senator Tolentino stated that the letter of apology showed the righteousness, correctness, and validity of the Filipino version of the said ramming incident. He likewise reiterated the necessity of the passage of his pending bill — the proposed Good Samaritan at Sea Law — which would ensure the safety and would guarantee civil compensation for all those who will be involved in similar incidents.
