AN ACT POSTPONING THE MAY 2020 BARANGAY AND SANGGUNIANG KABATAAN ELECTIONS, AMENDING FOR THE PURPOSE REPUBLIC ACT NO. 9164, AS AMENDED BY REPUBLIC ACT NO. 9340, REPUBLIC ACT NO. 10632, REPUBLIC ACT NO. 10656, REPUBLIC ACT NO. 10923, AND REPUBLIC ACT NO. 10952, AND FOR OTHER PURPOSES

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

- 1 SECTION 1. Section 1 of Republic Act No. 9164, as
- 2 amended, is hereby further amended to read as follows:
- 3 "Section 1. Date of Election. There shall
- 4 be synchronized barangay and sangguniang

1	kabataan elections, which shall be held on July
2	15, 2002. Subsequent synchronized barangay
3	and sangguniang kabataan elections shall be
4	held on the last Monday of October 2007 and
5	every three (3) years thereafter: Provided, That
6	the barangay and sangguniang kabataan
7	elections on [October 23, 2017] THE SECOND
8	MONDAY OF MAY 2020 shall be postponed to
9	[the second Monday of May 2018] DECEMBER
10	5, 2022. Subsequent synchronized barangay and
11	sangguniang kabataan elections shall be held on
12	the [second Monday of May 2020] FIRST
13	MONDAY OF DECEMBER 2025 and every
14	three (3) years thereafter."
15	SEC. 2. Section 4 of Republic Act No. 9164, as
16	amended, is hereby further amended to read as follows:
17	"SEC. 4. Assumption of Office The term of
18	office of the barangay and sangguniang
19	kabataan officials elected under this Act shall
20	commence at noon of June 30 next following

their election: Provided, however, That the term 1 of office of the barangay and sangguniang 2 kabataan officials elected in the [May 2020] 3 DECEMBER 5, 2022 elections and subsequently 4 5 thereafter, shall commence at noon of [June 30] JANUARY 1 next following their election." 6 SEC. 3. Hold Over. - Until their successors shall have 7 8 been duly elected and qualified, all incumbent barangay 9 and sangguniang kabataan officials shall remain in office, 10 unless sooner removed or suspended for cause: Provided, That barangay and sangguniang kabataan officials who 11 12 are ex officio members of the sangguniang bayan, 13 sangguniang panlungsod, or sangguniang panlalawigan shall continue to serve as such members in the sanggunian 14 concerned until June 30, 2020. The Liga ng mga Barangay 15 16 and the Pederasyon ng Sangguniang Kabataan at the 17 municipal, city, and provincial levels shall, not later than 18 June 30, 2020, conduct election for ex officio positions in 19 the sanggunians.

1	SEC. 4. Appropriations The amount necessary for
2	the implementation of this Act shall be taken from the
3	appropriations of the Commission on Elections
4	(COMELEC) under the General Appropriations Act and/or
5	supplementary appropriations thereafter.
6	SEC. 5. Repealing Clause All other laws, acts
7	presidential decrees, executive orders, issuances
8	presidential proclamations, rules and regulations or parts
9	thereof, which are contrary to and inconsistent with any
10	provision of this Act, are hereby repealed, amended, or
11	modified accordingly.
12	SEC. 6. Separability Clause If any portion or
13	provision of this Act is declared unconstitutional, the
14	remainder of this Act or any provision not affected thereby
15	shall remain in force and effect.
16	SEC. 7. Effectivity This Act shall take effect
17	immediately following the completion of its publication
18	either in the Official Gazette, or in two (2) newspapers o
19	general circulation in the Philippines.
