SPONSORSHIP SPEECH OF SENATE PRESIDENT SOTTO

Senate President Sotto presented to the Body Proposed Senate Resolution No. 135 expressing the profound sympathy and condolences of the Senate on the death of former Senator Rene G. Espina.

Following is the full text of Senate President Sotto's sponsorship speech:

One's legacy upon death is not dependent on the eloquence of those who deliver eulogies, for it would be dangerous to rely on orators to make a verdict on how a life was lived. Words are inadequate to match the speech that has been delivered through the life well lived by Senator, Governor, Cabinet Secretary, Administrator, lawyer, host, and columnist Jose Marino "Rene" G. Espina.

Although nothing much has been written about him, Sen. Rene Espina's accomplishments and positions held in the government had a lot to say about his prominence. In all the titles and positions he held, he always made it a point to leave a mark:

As a lawyer – he was one of the topnotchers during his time;

As an administrator and chairman of the SSS – he introduced the first computer system in government;

As governor of Cebu – he was awarded as the Most Outstanding Governor in the Philippines in 1968 to 1969;

As Secretary of Public Works, Transportation and Communications – he was fondly called as the "Builder and Father of Mactan-Mandaue Bridge" for being the one behind its construction; and

As a senator – he crafted the first anti-drug law, which is the Dangerous Drugs Act of 1972, a precursor of RA 9165 or the Comprehensive Dangerous Drugs Act of 2002, which this Representation is principal author in the Senate and our Majority Leader, Sen. Migz Zubiri, its principal author in the House of Representatives. We both share the same convictions of having a drug-free Philippines, and this present Congress will continue to thrive with his legacy that he left this nation. He was voted as one of the "Most Outstanding Senators" during his tenure.

Senator Espina's presence and service to the people did not end when his term of office as public servant ended. He continued to do civic and social works out of the limelight and received various awards for the same.

Truly, no words can measure up to the speech spoken by the life of Senator Espina for, truly, his actions speak louder that our words. He lived by the saying: "The great use of life is to spend it for something that will outlast it." Indeed, what he left behind is something that even the heirs of his heirs will enjoy—which is a better Philippines.

Upon motion of Senator Zubiri, there being no objection, the Body approved the transfer of Committee Report No. 4 on Senate Bill No. 1043 from the Calendar for Ordinary Business to the Calendar for Special Orders.

COMMITTEE REPORT NO. 4 ON SENATE BILL NO. 1043

Upon motion of Senator Zubiri, there being no objection, the Body considered, on Second Reading, Senate Bill No. 1043 (Committee Report No. 4), entitled

AN ACT POSTPONING THE MAY 2020 BARANGAY AND SANGGUNIANG KABATAAN ELECTIONS, AMENDING FOR THE PURPOSE REPUBLIC ACT NO. 9164, AS AMENDED BY REPUBLIC ACT NO. 10632, REPUBLIC ACT NO. 10656, REPUBLIC ACT NO. 10923, AND REPUBLIC ACT NO. 10952, AND FOR OTHER PURPOSES.

Pursuant to Section 67, Rule XXIII of the Rules of the Senate, with the permission of the Body, upon motion of Senator Zubiri, only the title of the bill was read without prejudice to the insertion of its full text into the Record of the Senate.

Thereupon, the Chair recognized Senator Marcos, Sponsor of the measure.

SPONSORSHIP SPEECH OF SENATOR MARCOS

Senator Marcos submitted to the Body Committee Report No. 4 on Senate Bill No. 1043, entitled "An Act Postponing the May 2020 Barangay and Sangguniang Kabataan Elections, Amending for the Purpose Republic Act No. 9164, as Amended by Republic Act No. 9340, Republic Act No. 10632, Republic Act No. 10656, Republic Act No. 10923, and Republic Act No. 10952, and for Other Purposes," as she underscored the urgency of postponing the barangay and SK election.

Following is the full text of Senator Marcos' speech:

As a single senator who derives directly from the barangays and the old Kabataang Barangay, we seek to postpone the barangay and SK elections, revising their elections scheduled by RA 10952 in 2017 on the second Monday of May 2020, to the second Monday of 2023.

This urgent postponement is sought first and foremost because proceeding with an early election next year would be in flagrant violation of the law, both the Local Government Code and R.A. No. 9164 which both clearly established the terms of barangay and SK officials at the period of three years. By May of 2020, all incumbent barangay officials would have sat a mere two years, hardly time to perform their duties or to plan their programs. Overwhelmed by the plethora of functions now assigned to the barangays by a spate of recent laws — drug rehabilitation, antiilliteracy, dengue, vaccination, child nutrition and, just lately, even road clearing, the barangay officials have not had a breather to plan or prioritize.

It is also time that we finally settled the calendar for barangay elections so that every year, in May, following national elections, the barangays and the SKs will know predictably and reliably that their elections will be next.

While SKs from the bigger local government units may be implementing their plans, most smaller LGUs are still undergoing the mandatory process of training their SKs. A 2020 election would clearly be impractical and impracticable for both barangays and these SKs. The SK Reform Act mandates a three-year plan, a Comprehensive Barangay Youth Development Plan. Surely, they will be far busier campaigning than planning if the election in May proceeds next year.

Further, the barangays protest that such a short term is operationally and financially unworkable. Following a six-month delay in the national budget's release last year, the barangays have just begun to finally access their local funds in the last few months. In compliance with the SK Reform Act and its new requisites, the SKs, in the meantime, continue to await new procurement guidelines for their projects. The bidding processes that will prevail would still be formulated, finalized, and enforced by the Government Procurement Policy Board.

Thus, this measure is urgent. To date, Comelec has luckily not spent any significant amount for the 2020 barangay and SK elections. Still, time, energy, and some expense are being lost. Already, registration is ongoing at the barangay and SK levels. Preparations for the procurement, short of award for carbonless paper and other require-

ments for ballots, are ongoing, anticipating a total budget of P37,896,250.00. Worse, our national budget for 2020 is pending and should shortly be passed including therein an item for P5.8 billion for the barangay and SK elections that could be put to other better uses more essential for our other needy sectors.

Barangay elections actually involve 62,963,305 registered voters. There are SKs in upwards of 21,100,858 registered in all our barangays. While the national elections open a mere 18,000 positions, in a barangay or SK elections, 672,448 positions are at stake. Further, barangay elections are manual, they are not automated-and let us recall we have urged the Comelec, the DICT, the DOST, to formulate a new and improved hybrid automated system for 2022. There is much work, indeed, to be done. Of course, the Comelec has said, "Kaya naman siguro, we are good soldiers," but they also had to admit "baka may makocompromise." Iyon po ang transcript sa kanilang budget. And the question indeed arises, will the results be satisfactory?

At the end, let us postpone because if we do not postpone, we may erode our sacred right of suffrage. We must not compromise at any point the Filipino right to vote most especially a vote for the barangay and the youth through which our popular will is so directly and fulsomely expressed.

Ang sabi nga ng mga bata, "Ang boto ay dapat parang pag-ibig—priceless." Ano man ang hirap at sakripisyo, kailangang gawin natin para buong puso at walang pag-aatubili ang pagboto.

The ancient *balangay* boats brought our forefathers to the new islands of hope—the archipelago that is today the Republic of the Philippines. We pray that this measure will bring new hope to those in our barangays and those in our youth sector.

COSPONSORSHIP SPEECH OF SENATOR TOLENTINO

Senator Tolentino stated that as chairman of the Senate Committee on Local Government, the committee that jointly heard the bill, he was supporting Senate Bill No. 1043, entitled "An Act Postponing the May 2020 Barangay and Sangguniang Kabataan Elections". He agreed with Senator Marcos, as well as the other senators who proposed similar bills, namely, Senators Go, Revilla, Binay, and Gatchalian, on the rationale, the necessity and the urgency of expeditiously passing this SONA legislative measure.

Following is the full text of Senator Tolentino's cosponsorship speech:

The Barangay and the Sangguniang Kabataan are vital pillars to our democracy. The barangay, being the most basic political unit of our country that is in the frontlines of providing essential government services to our communities, and the Sangguniang Kabataan (SK), which helps mold young leaders for the country's future, must always be given primary importance. Thus, it only follows that these units of government must always be afforded the opportunity and time to perform their very important functions and duties. However, with the existing law on barangay elections and the realities these local government units have been facing since their assumption into office, it would seem that they have been denied the chance to fully, competently, and completely serve.

Kagaya po ng narinig ko kanina, kulang po iyong dalawang taon. Kai-eleksyon lamang po, mag-eeleksyon na po muli.

Republic Act 9164, as amended, provides that the current set of officers elected on the elections of May 2018 shall only serve for two (2) years as there will be another election for the same positions on May 2020. Therefore, the existing officials are only going to serve for two years. As expressed by the resource persons during the committee hearings, this is not enough. Two years or 24 months is not enough for the barangay and SK officials to conduct their trainings, perform their mandates as well as the new directives issued by the President regarding cleanup operations. With this bill, there is new hope for the accomplishment of these tasks.

This bill likewise meets the concerns of the Commission on Elections in having at least a one-year gap, or break, so to speak, between national and local elections and the barangay and SK elections to enable this hardworking Constitutional Commission to fully prepare and ensure that democracy is exercised.

After this bill is passed, confusion on the schedule of barangay elections will now be cleared up. As from hereon, barangay and SK elections will be held a year after every national and local election, promising consistency, institutionalization, and stability in these basic but supremely important units of government.

On this note, this Representation firmly supports the postponement of the barangay and *Sangguniang Kabataan* elections to May 2023 and urges this august Body to approve the same.

COSPONSORSHIP SPEECH OF SENATOR GO

Senator Go also added his voice in supporting Senate Bill No. 1043 under Committee Report No. 4, postponing the barangay and *Sangguniang Kabataang* elections to May 2023, saying that he was one of the members of this Chamber who supported the passage of this measure, through Senate Bill No. 201 which he filed last July.

The rest of Senator Go's cosponsorship speech follows:

I support the postponement of the elections to 2023 as it will give the newly elected President a chance to work hand in hand with the new Barangay and SK officials, to synchronize and finish their projects and programs.

Hindi po kasalanan ng mga barangay officials ang postponement ng nakaraang eleksyon at dalawang taon na lamang po ang natitira sa kanila. As I have said with conviction many times before, our barangay officials are at the forefront when it comes to the delivery of the most basic and essential services to our people. Sila rin po ang nasa unahan sa ating matinding kampanya laban sa iligal na droga at kriminalidad. They are very important when it comes to addressing the most perennial problems faced by our countrymen.

As a matter of fact, in recognition of their unquantifiable contributions to the welfare of our people, I have also filed Senate Bill No. 391, which seeks to provide a Magna Carta for Barangays, and Senate Bill No. 392, which mandates the appointment of barangay health workers. These measures recognize the invaluable contributions and the crucial roles played by our barangay officials.

That is why, it is only fitting and proper that they be given sufficient and adequate time to properly implement and enact the projects and programs they have championed, for the benefit of their constituents who expect nothing less from them.

Finally, I believe that this postponement, more than anything, is for the constituents.

I urge my colleagues in this august Body to support this measure. And let us give the barangay leaders chosen by the people enough time to implement all the necessary and essential programs promised to them.

INTERPELLATION OF SENATOR REVILLA

Asked by Senator Revilla how many times the barangay and SK elections have been postponed prior to the May 2018 election, Senator Marcos said that from 1992 to 2018, the barangay elections have been postponed six times; while the SK elections have been postponed seven times.

Asked why Congress had to postpone the barangay and SK elections in the past, Senator Marcos explained that there were various reasons, one of which was its proximity to the national elections. Specifically, in the case of the SK, she said that no IRR and other guidelines have yet been established since the passage of the SK Reform Act of 2015. She said that the Committee felt the urgent need to postpone the elections because preparations for registration and ballot supply procurement were already ongoing and they would be put to waste if the elections would eventually be postponed.

Senator Revilla inquired about the dates considered by the Committee before it recommended the postponement of the May 2020 elections to May 2023. He informed the Body that his version of the bill was for the elections to be held in October 2022. In reply, Senator Marcos stated that both her and Senator Go's versions bore the same date as in Senator Revilla's bill, which is almost immediately after the national elections in May of the same year. However, she said that the Comelec had expressed concern over the original proposed date because they claimed that it would be difficult for them to prepare for two elections within the same year considering the weather and the school year. Thus, she said that the Committee instead agreed to hold the elections in May 2023 which is a year after the national elections so that the local executives, starting from the governor and mayor, down to the SK, would have the same term of office.

Senator Revilla noted that under the existing law, the term of office of the barangay and SK officials should be three years. But he pointed out that if elections were to be held in 2020, the officials would have served for only two years which is in violation of the law. He then asked if serving for five years would be in accordance with the law. In reply, Senator Marcos clarified that while Section 43(C) of the Local Government Code stipulates that barangay officials should have a three-year term, it is possible for their term to be made longer but not shorter, as

suggested by Senator Tolentino. She added the need for Congress to once and for all establish the calendar for all succeeding barangay and SK elections by making it clear that it should be held one year after the national elections, thereby complying with the three-year term rule.

Thereafter, Senator Revilla expressed his support for the measure.

SUSPENSION OF CONSIDERATION OF SENATE BILL NO. 1043

Upon motion of Senator Zubiri, there being no objection, the Body suspended consideration of the bill.
