Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1	SECTION 1. Section 65 of the 2019 General Appropriations Act
2	or Republic Act No. 11260 is hereby amended to read as follows:
3	"SEC. 65. Availability of Appropriations All
4	appropriations authorized in this Act shall be available
5	for release and obligation for the purpose specified.

I	and under the same special provisions applicable
2	thereto, until [December 31, 2019] DECEMBER 31,
3	2020.
4	"A report on these releases and obligations shall
5	be submitted to the Speaker of the House of
6	Representatives, the President of the Senate of the
7	Philippines, the House Committee on Appropriations
8	and the Senate Committee of Finance, either in printed
9	form or by way of electronic document."
10	SEC. 2. Repealing Clause All laws, decrees, executive
II	issuances, rules and regulations inconsistent with this Act
12	are hereby repealed or modified accordingly.
1.3	SEC. 3. Effectivity This Act shall take effect fifteen (15)
4	days after its publication in the Official Gazette or in a newspaper of
5	general circulation.
