**AN ACT  
RENAMING THE RANK CLASSIFICATION IN THE BUREAU OF JAIL  
MANAGEMENT AND PENOLOGY, AMENDING FOR THE PURPOSE REPUBLIC  
ACT NO. 6975, OTHERWISE KNOWN AS THE DEPARTMENT OF INTERIOR  
AND LOCAL GOVERNMENT ACT OF 1990**

**EXPLANATORY NOTE**

This bill seeks to modify the rank classification of the personnel of the Bureau of Jail and Penology. This is in consonance with the enactment of Republic Act No. 11200, otherwise known as An Act Providing for the Rank Classification in the Philippine National Police, Amending for the Purpose Section 28 of Republic Act No. 6975, as amended in June 2019.

This proposed measure aims to minimize confusion and enhance public's understanding of the different bureaus. Furthermore, this bill seeks to enhance efficiency in inter-agency operations, in general.

In view of the foregoing, passage of this bill is earnestly sought.

**AN ACT**  
**RENAMING THE RANK CLASSIFICATION IN THE BUREAU OF JAIL**  
**MANAGEMENT AND PENOLOGY, AMENDING FOR THE PURPOSE REPUBLIC**  
**ACT NO. 6975, OTHERWISE KNOWN AS THE DEPARTMENT OF INTERIOR**  
**AND LOCAL GOVERNMENT ACT OF 1990**

*Be it enacted by the Senate and House of Representatives of the Congress assembled:*

1 Section 1. Section 64 of Republic Act No. 6975, otherwise known as the  
2 Department of the Interior and Local Government Act of 1990, is hereby amended to  
3 read as follows:

5 Sec. 64. Rank Classification – For purposes of efficient  
6 administration, supervision and control, the rank classification of  
7 the members of the Jail Bureau shall be as follows:

9 [Director] **JAIL MAJOR GENERAL**

10 [Chief Superintendent] **JAIL BRIGADIER GENERAL**

11 [Senior Superintendent] **JAIL COLONEL**

12 [Superintendent] **JAIL LIEUTENANT COLONEL**

13 [Chief Inspector] **JAIL MAJOR**

14 [Senior Inspector] **JAIL CAPTAIN**

15 [Inspector] **JAIL LIEUTENANT**

16 [Senior Jail Officer IV] **JAIL EXECUTIVE MASTER SERGEANT**

1 [Senior Jail Officer III] **JAIL CHIEF MASTER SERGEANT**

2 [Senior Jail Officer II] **JAIL SENIOR MASTER SERGEANT**

3 [Senior Jail Officer I] **JAIL MASTER SERGEANT**

4 [Jail Officer III] **JAIL STAFF SERGEANT**

8 Sec. 2. Within thirty (30) days from the effectivity of this Act, the Head of the  
9 Bureau of Jail Management and Penology shall issue the necessary rules and  
10 regulations for the effective implementation of this Act.

11  
12 Sec. 3. *Separability Clause.* If any provision or part hereof, is held invalid or  
13 unconstitutional, the remainder of the law or the provision not otherwise affected shall  
14 remain valid and subsisting.

15  
16 Sec. 4. *Repealing Clause.* Any law, presidential decree or issuance, executive  
17 order, letter of instruction, administrative order, rule or regulation contrary to, or  
18 inconsistent with the provisions of this Act is hereby repealed, modified or amended  
19 accordingly.

20  
21 Sec. 5. *Effectivity Clause.* This Act shall take effect fifteen (15) days after its  
22 publication in at least two (2) newspapers of general circulation.
