

Recommending the approval of House Bill No. 5871 with amendments.

Sponsor : Sen. Christopher Bong Go

Mr. President:

The Committees on Health and Demography, and Finance, to which was referred House Bill No. 5871, introduced by Representative Tan (A.), entitled:

AN ACT
UPGRADING THE MARIA L. ELEAZAR DISTRICT HOSPITAL IN THE MUNICIPALITY OF TAGKAWAYAN, PROVINCE OF QUEZON INTO A LEVEL III GENERAL HOSPITAL TO BE KNOWN AS THE MARIA L. ELEAZAR GENERAL HOSPITAL, UNDER THE DIRECT SUPERVISION AND CONTROL OF THE DEPARTMENT OF HEALTH, AND APPROPRIATING FUNDS THEREFOR

have considered the same and have the honor to report back to the Senate with the recommendation that House Bill No. 1477 be approved with the following amendments:

1. On page 1, line 6, between the words "The" and "bed", insert the phrase "**INCREASE IN THE**".
2. On the same page, lines 8 and 9, delete the phrase "that shall be prepared by the DOH".
3. On page 2, before line 1, insert two new Sections, which shall read as follows:

"SEC. 3. THE DOH, IN COORDINATION WITH THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) AND THE CIVIL SERVICE COMMISSION (CSC), AND IN CONSULTATION WITH THE MANAGEMENT OF THE HOSPITAL, SHALL DETERMINE THE ADDITIONAL PLANTILLA POSITIONS TO BE CREATED AND FILLED UP IN THE WORKFORCE OF THE SAID HOSPITAL."

"SEC. 4. THE CHIEF OF THE HOSPITAL SHALL DEVELOP A HOSPITAL DEVELOPMENT PLAN TO BE SUBMITTED TO THE DOH TO REFLECT THE DEVELOPMENT GOALS OF THE HOSPITAL, CONSISTENT WITH THE INCREASE IN BED CAPACITY AND SERVICE CAPABILITY. REQUEST FOR THE STAFFING REQUIREMENTS, CAPITAL OUTLAY INVESTMENTS AND BUDGETARY NEEDS FOR OPERATIONS SHALL BE BASED ON THE HOSPITAL DEVELOPMENT PLAN."

4. Renumber the succeeding sections accordingly.

5. On page 2, after line 8, insert two new Sections, which shall read as follows:

"SEC. 7. IF ANY PROVISION OR PART OF THIS ACT IS DECLARED UNCONSTITUTIONAL, THE REMAINING PARTS OR PROVISIONS NOT AFFECTED SHALL REMAIN IN FULL FORCE AND EFFECT."

"SEC. 8. ALL LAWS, EXECUTIVE ORDERS, ISSUANCES, RULES AND REGULATIONS INCONSISTENT WITH THIS ACT ARE HEREBY REPEALED OR MODIFIED ACCORDINGLY."

6. Renumber the succeeding section accordingly.

DEPARTMENT OF HEALTH, AND APPROPRIATING FUNDS
THEREFOR

*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

1 SECTION 1. The Maria L. Eleazar District Hospital in the
2 Municipality of Tagkawayan, Province of Quezon is hereby upgraded
3 into a Level III general hospital to be known as the Maria L. Eleazar
4 General Hospital, under the direct supervision and control of the
5 Department of Health (DOH).

6 The bed capacity of the Maria L. Eleazar General Hospital in
7 the Municipality of Tagkawayan, Province of Quezon shall be
8 implemented in accordance with the hospital development plan that
9 shall be prepared by the DOH.

10 SEC. 2. The existing professional health care services and
11 facilities are also hereby upgraded to conform with and be
12 commensurate to the bed capacity increase as provided in Section 1
13 hereof.
