

**Mr. President:**

The Committees on Health and Demography, and Finance, to which was referred House Bill No. 6144, introduced by Representatives Lara, Vargas Alfonso, Chungalao, et. al., entitled:

**AN ACT  
INCREASING THE BED CAPACITY OF THE CAGAYAN VALLEY  
MEDICAL CENTER (CVMC) IN TUGUEGARAO CITY, PROVINCE OF  
CAGAYAN, FROM FIVE HUNDRED (500) TO ONE THOUSAND  
(1,000) BEDS AND APPROPRIATING FUNDS THEREFOR**

and taking into consideration Senate Bill No. 1103, introduced by Senator Marcos, entitled:

**AN ACT  
INCREASING THE BED CAPACITY OF THE CAGAYAN VALLEY  
MEDICAL CENTER (CVMC) IN TUGUEGARAO CITY, PROVINCE OF  
CAGAYAN, FROM FIVE HUNDRED (500) TO ONE THOUSAND  
(1,000) BEDS AND APPROPRIATING FUNDS THEREFOR**

have considered the same and have the honor to report back to the Senate with the recommendation that House Bill No. 6144, taking into consideration Senate Bill No. 1103, be approved with the following amendments:

1. On page 2, line 2, after word hereof, insert a comma (,) and the phrase **"CONSISTENT WITH THE HOSPITAL DEVELOPMENT PLAN"**.
2. On the same page, line 5, after the word "correspondingly", insert a comma (,) and the phrase **"CONSISTENT WITH THE HOSPITAL DEVELOPMENT PLAN."**
3. On the same page, after line 13, insert two new Sections, which shall read as follows:  
**"SEC. 5. IF ANY PROVISION OR PART OF THIS ACT IS DECLARED UNCONSTITUTIONAL, THE REMAINING PARTS OR PROVISIONS NOT AFFECTED SHALL REMAIN IN FULL FORCE AND EFFECT."**  
**"SEC. 6. ALL LAWS, EXECUTIVE ORDERS, ISSUANCES, RULES AND REGULATIONS INCONSISTENT WITH THIS ACT ARE HEREBY REPEALED OR MODIFIED ACCORDINGLY."**
4. Renumber the succeeding section accordingly.

AN ACT INCREASING THE BED CAPACITY OF THE CAGAYAN VALLEY MEDICAL CENTER (CVMC) IN TUGUEGARAO CITY, PROVINCE OF CAGAYAN, FROM FIVE HUNDRED (500) TO ONE THOUSAND (1,000) BEDS AND APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:*

1           SECTION 1. The bed capacity of the Cagayan Valley Medical  
2 Center (CVMC) shall be increased from five hundred (500) to one  
3 thousand (1,000) beds. Any future increase in bed capacity shall be  
4 consistent with the hospital development plan which shall be  
5 prepared and submitted by the Medical Center Chief of the CVMC  
6 to the Department of Health (DOH) to reflect the development goals  
7 of the hospital.

8           SEC. 2. The existing professional health care services and  
9 facilities of the CVMC are also hereby upgraded to conform with

1 and be commensurate to the increase in bed capacity as provided for  
2 in Section 1 hereof.

3 SEC. 3. The existing workforce of the CVMC, which includes  
4 doctors, nurses, and support personnel, shall also be increased  
5 correspondingly. The Secretary of the DOH shall, after consultation  
6 with the Medical Center Chief of the CVMC, and in coordination  
7 with the Secretary of the Department of Budget and Management  
8 and the Commissioner of the Civil Service Commission, determine  
9 the additional new positions to be created and filled up.

10 SEC. 4. The Secretary of Health shall immediately include in  
11 the program of the DOH the implementation of this Act, the funding  
12 of which shall be included in the annual General Appropriations  
13 Act.

14 SEC. 5. This Act shall take effect fifteen (15) days after  
15 its publication in the *Official Gazette* or in a national newspaper of  
16 general circulation.
