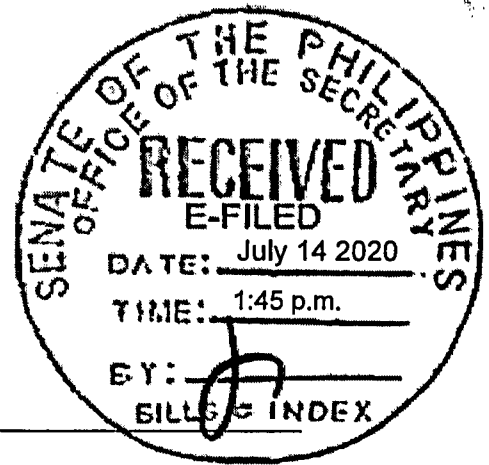

THEREFOR


EXPLANATORY NOTE

Education is a human right, this is enshrined in Article XIV, Section 1 of the 1987 Constitution, which states that the state shall protect and promote the right of all citizens to quality education at all levels and shall take appropriate steps to make such education accessible to all. Furthermore, Article II, Section 17 states that the State shall give priority to education.

Pursuant to the aforementioned constitutional mandate, this bill proposes to establish a national high school in Barangay Quibal, Municipality of Peñablanca, Province of Cagayan, to be known as the Quibal National High School. The establishment of a national high school in Quibal will greatly benefit students living in neighboring barangays. This would mean that the students of the municipality of Quibal will no longer need to travel far for education.

Thus, it is imperative that a national high school be established to maintain, and support a complete, adequate, and integrated system of education that is relevant to the needs of the people and society. Thus, the establishment of the Quibal National High School is important to ensure that the youth of Cagayan is provided with accessible and quality education.

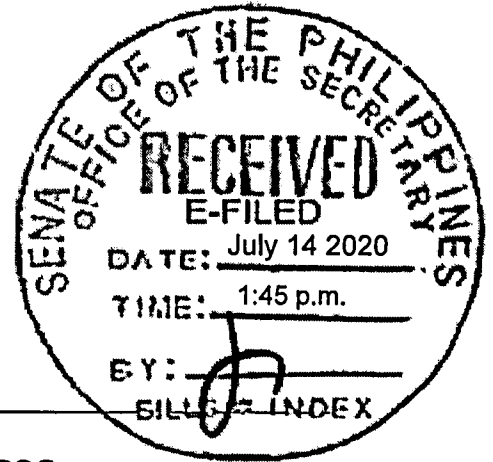
In view of the foregoing, this representation earnestly seeks your support for the approval of this bill.

AN ACT
ESTABLISHING A NATIONAL HIGH SCHOOL IN BARANGAY QUIBAL,
MUNICIPALITY OF PEÑABLANCA, PROVINCE OF CAGAYAN TO BE KNOWN
AS QUIBAL NATIONAL HIGH SCHOOL AND APPROPRIATING FUNDS
THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 **Section 1.** There is hereby established, under the supervision of the
2 Department of Education, a national high school in Barangay Quibal, Municipality of
3 Peñablanca, Province of Cagayan, to be known as the Quibal National High School.

4 **Sec. 2.** The Secretary of Education shall immediately include in the Department
5 of Education's program, the operationalization of the Quibal National High School, the
6 funding of which shall be included in the annual General Appropriations Act.

7 **Sec. 3.** The Secretary of Education shall issue such rules and regulations as
8 may be necessary to carry out the purposes of this Act.

9 **Sec. 4.** All laws, decrees, orders, rules and regulations, or other issuances or
10 parts thereof inconsistent with the provisions of this Act are hereby repealed or
11 modified accordingly.

12 **Sec. 5.** If any portion or provision of this act is declared unconstitutional, the
13 remainder of this Act or any provision not affected thereby shall remain in force and
14 effect.

15 **Sec. 6.** This Act shall take effect fifteen (15) days after its publication in two
16 (2) newspapers of general circulation.
