

	Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:
1	SECTION 1. The Second Legislative District of the Province of
2	Rizal is hereby reapportioned into three (3) legislative districts, to
3	take effect in the 2022 national and local elections. Each legislative
4	district shall be composed of the following municipalities:

7	(2) Baras
8	(3) Tanay
9	(4) Morong

5 SEC. 2. The Commission on Elections shall issue the 6 necessary implementing rules and regulations within thirty (30) 7 days after the effectivity of this Act.

8 SEC. 3. All laws, rules and regulations which are inconsistent 9 with this Act are hereby repealed or amended accordingly.

10 SEC. 4. This Act shall take effect fifteen (15) days after its 11 publication in the *Official Gazette* or in a newspaper of general 12 circulation.

- AN ACT COMMEMORATING THE CITYHOOD OF SAN JOSE DEL MONTE, PROVINCE OF BULACAN THROUGH THE ANNUAL CELEBRATION OF THE TANGLAWAN FESTIVAL ON THE OCCASION OF ITS FOUNDATION DAY ON SEPTEMBER 10, AMENDING FOR THE PURPOSE REPUBLIC ACT NO. 9750
- Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. Section 1 of Republic Act No. 9750 is hereby amended to read as follows:

"SECTION 1. September 10 of every year is 3 hereby declared [to be] a special nonworking 4 holiday in the City of San Jose del Monte, 5 Province of Bulacan [to commemorate its 6 founding day and IN COMMEMORATION OF ITS 7 CITYHOOD. [to] IT SHALL be known as the 8 9 "Foundation Day of the City of San Jose del 10 Monte' AND SHALL BE CELEBRATED ANNUALLY 11 THROUGH THE TANGLAWAN FESTIVAL'."

1 SEC. 2. This Act shall take effect fifteen (15) days after 2 its publication in the *Official Gazette* or in a newspaper of 3 general circulation.
